Subject:	2020 annual increases to Seattle minimum wage, penalties, and fines

The City of Seattle Office of Labor Standards announces the required increase to the 2020 Seattle minimum wage for large employers as defined by SMC 14.19, and increases to all penalties and fines in other labor standards, to reflect the annual rate of inflation.

2020 Seattle Minimum Wage for large employers (501 or more employees)

Statutory Authority

<u>SMC 14.16.010</u>, <u>14.17.010</u>, <u>14.19.010</u>, <u>14.20.010</u>, <u>14.22.010</u>, <u>14.23.010</u>

"Rate of inflation" means 100 percent of the annual average growth rate of the bi-monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and Clerical Workers, termed CPI-W, for the 12month period ending in August, provided that the percentage increase shall not be less than zero.

SMC 14.19.030 - Hourly Minimum Wage - Schedule 1 Employers

Effective January 1, 2018, the hourly minimum wage paid by a Schedule 1 employer to any employee shall be increased annually on a percentage basis to reflect the rate of inflation and calculated to the nearest cent on January 1 of each year thereafter.

SMC 14.16.080, 14.17.055, 14.19.080, 14.20.060, 14.22.095

Effective January 1, 2017, the amounts of all civil penalties, penalties payable to aggrieved parties, and fines contained in this <u>Section 14.19.080</u> shall be increased annually to reflect the rate of inflation and calculated to the nearest cent on January 1 of each year thereafter. The Agency shall determine the amounts and file a schedule of such amounts with the City Clerk.

SMC 14.23.095

Effective July 1, 2019, the amounts of all civil penalties and penalties payable to aggrieved parties contained in this Section 14.23.095 shall be increased to reflect the rate of inflation and calculated to the nearest cent on January 1 of each year. The Agency shall determine the amounts and file a schedule of such amounts with the City Clerk.
