This action is based upon the criteria set forth in Title 84 RCW Chapter 449; and based on the review and approval of the building exterior renovation by the Ballard Avenue Landmark District Board; that the property is a contributing building located in the Ballard Avenue Landmark District, and has not been altered in any way that adversely affects those features that identify its significance or contribution to the Ballard Avenue Landmark District; that the property has been issued Certificates of Approval as required in the Ballard Avenue Landmark District; and has substantially improved in the 24-month period prior to application, and that the recommendation is conditioned upon the execution of an agreement between the Local Review Board as required by Title 84 RCW, Chapter 449. Cass O'Callaghan seconded the motion.
