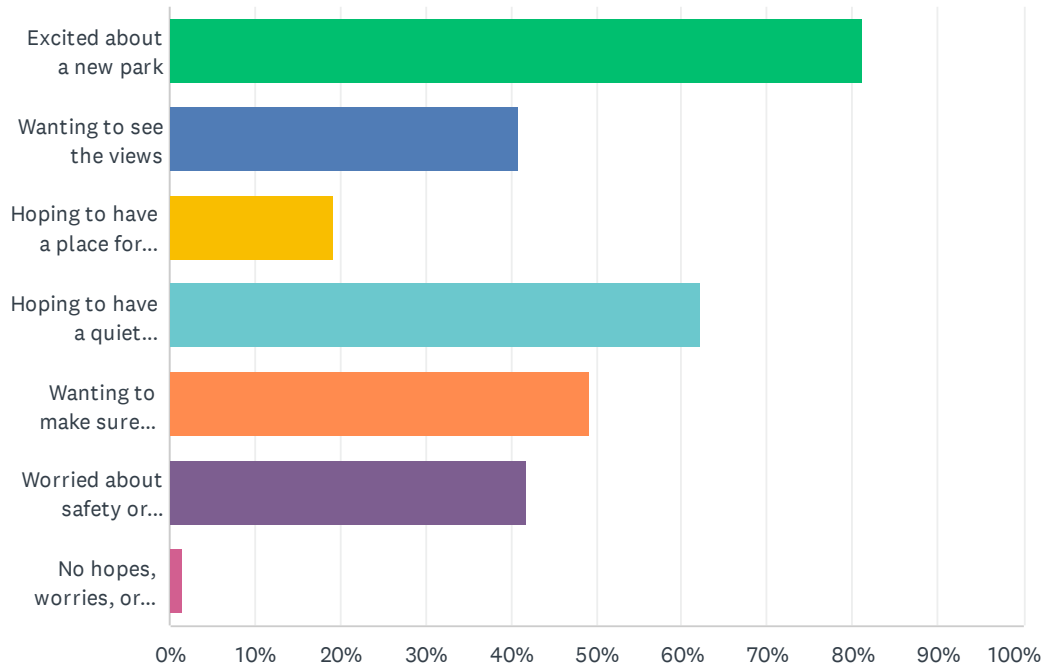


Q1 Do you have hopes or worries about the future park site? Please check all that apply

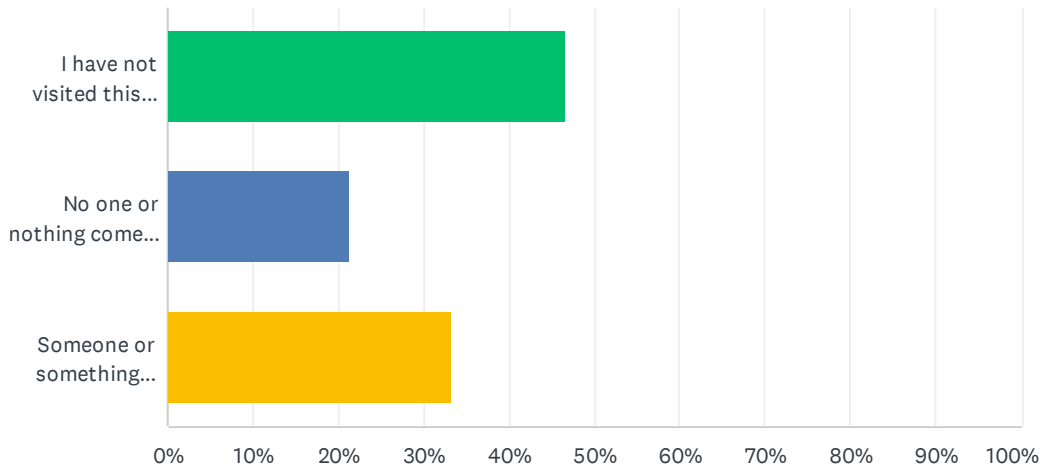

The volunteers have built a welcoming, joyful community. We hope to continue with the garden, and continue to build on this effective and joyful community.

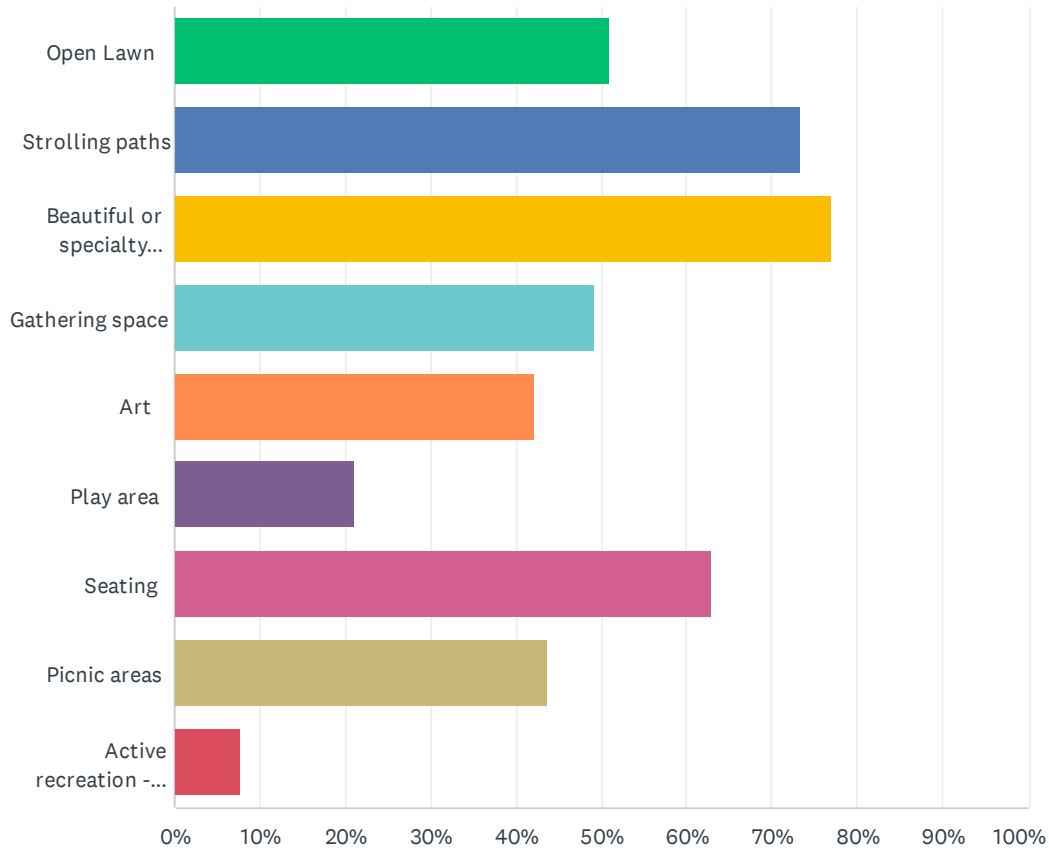

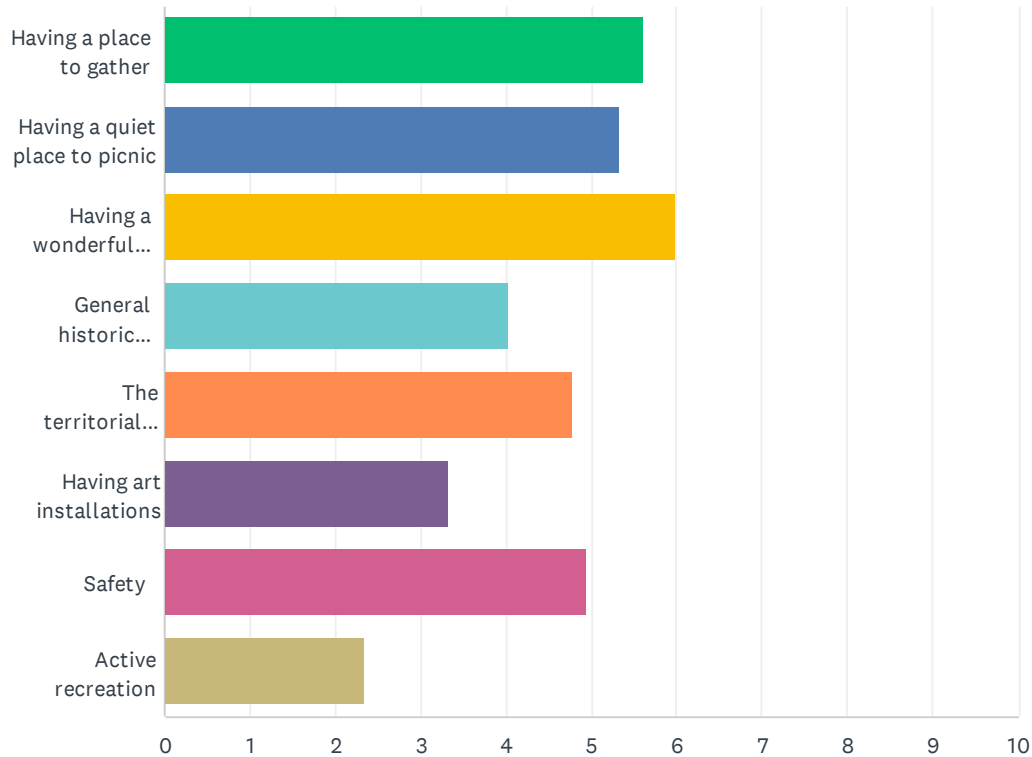

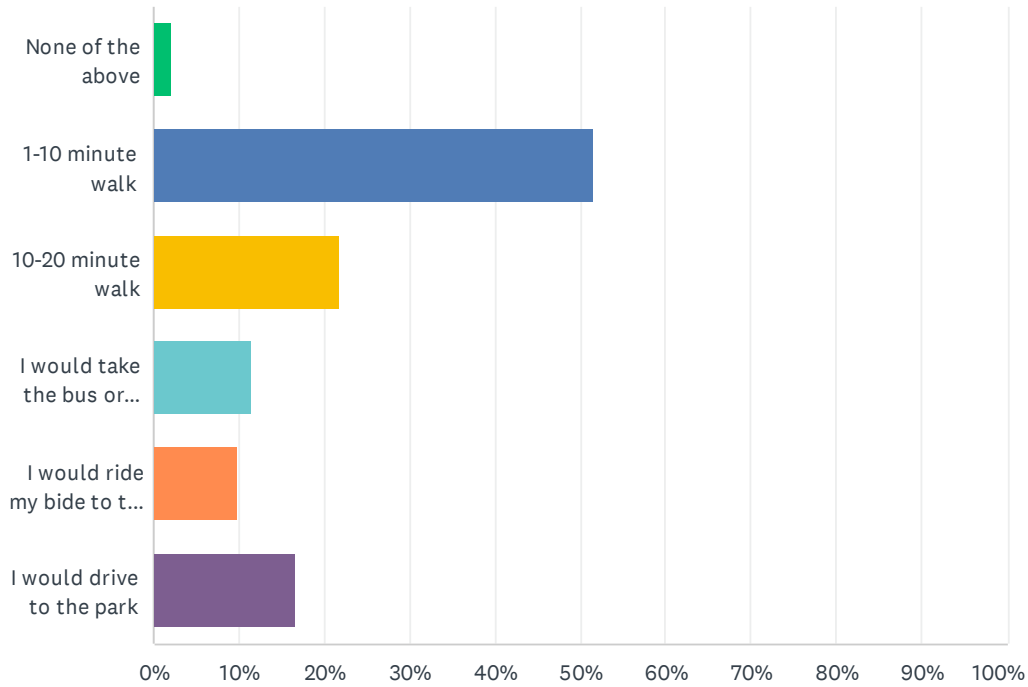
