### Community Engagement Committee Update

The Community Engagement Team posted a position for an additional Community Engagement Specialist. The Community Engagement Team is creating a CPC Law Enforcement 101 PowerPoint presentation and is working with the Policy Team to creating metrics to evaluate their engagement efforts. The team is also working on a Community Engagement Plan for the SDFIT Taskforce report. Lastly, the team is updating the CPC’s Rapid Response Protocol.

### Behavioral Health Workgroup

An update was provided on the Lyles Force Review Board Findings, the CIT Trainings given to SPD Officers, workgroup Ride-Alongs, and their critical review of Ricky’s Law.

### **Police Practices Workgroup**

An update was provided on Coercive Interrogations, the Disparity Audit, Preference Points, and Demonstration Management. Regarding the Disparity Audit, the workgroup will redline the draft methodology and provide a counter-proposal. The workgroup will also request from the DOJ the previous assessment that Dr. McDevitt was assigned. The OIG was present to discuss Coercive Interrogations. The workgroup and IG discussed collaborating on addressing coercive interrogation techniques used by SPD. The group discussed potentially developing a model template similar to SPD's de-escalation and force policies; a template that would embed a value. The IG gave an update on conversations that she is having with the National and Local Innocence Project. Action Items were identified.
