Your City of Seattle Business Taxes



Every business must file and report to the City, even if you had no activity or do not owe any tax. Your business does not owe general business and occupation (B&O) tax if your net annual income is less than \$100,000, but **you must file**.

- Apply for a business license
- Renew a business license
- File your business taxes
- Pay your business taxes

Create an account with:

1. Your Seattle Business License Tax Certificate Number, or
2. Your Washington State business license number (UBI, Uniform Business Identifier).
