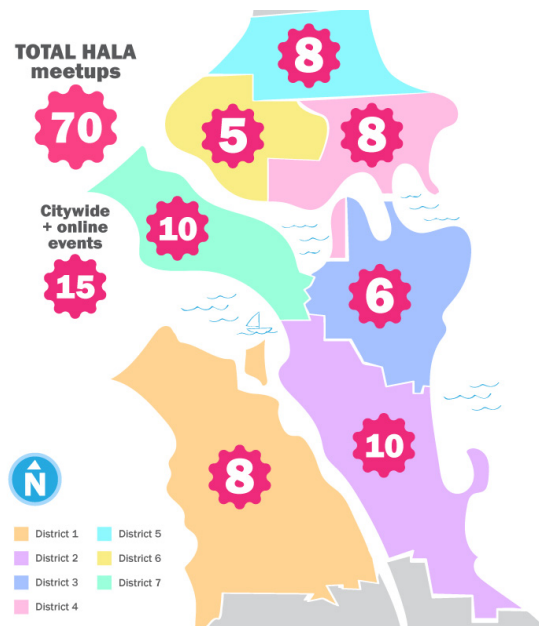

## CELEBRATING OUR ACCOMPLISHMENTS

Looking back on the last several months of HALA work, there are many accomplishments. Thank you for your input, your time and thank you for continuing to support the Seattle Housing Levy. It's obvious that Seattleites want an affordable city for all.

[Some highlights are:](#)

- Seattle voters renewed and expanded the Seattle Housing Levy
- The following addition tenant protections were put into place: Source of Income Discrimination, Improvement of Tenants Rights, Tenant Relocation Assistance
- Multifamily Tax Exemption was expanded to allow for the construction of more affordable housing, especially family-sized homes.
- The community has made important contributions to the development of Mandatory Housing Affordability Residential Framework

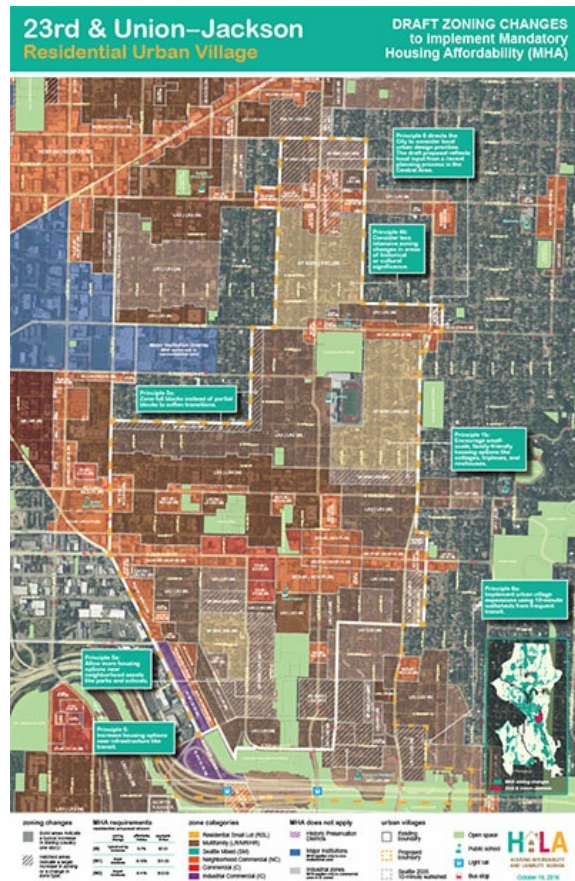
## Draft maps for neighborhoods out now: Please tell us your thoughts on MHA proposed zoning changes.

We have released DRAFT maps for your review. Extensive community outreach has brought constructive ideas and local knowledge to the process of developing principles and those principles are reflected in draft proposed zoning changes.
