The COVID-19 virus has greatly impacted the Seattle-King County region. The City of Seattle, in compliance with <u>Local Health Orders</u>, is taking proactive measures designed to slow the spread of the virus and keep both residents and visitors to our city safe.

This letter is to inform you the Public Safety Civil Service Commission, in response to Governor Inslee's "Safe Start" phased in approach to reopening, has postponed promotional testing to later dates in June, July, and August to combat the spread of COVID-19.
