4. APPROVAL OF MINUTES

Approval of Minutes June 23, 2021, Special Meeting

The Commission reviewed the minutes of the June 23, 2021, special meeting. Commissioner Connole moved to amend the minutes re the Case Status Report/Moss Rivera Update, to state that "Officer Moss already acknowledged that the issue pending is moot and is giving Officer Rivera an opportunity to respond." Commissioner Nark seconded the motion. The minutes were approved with the stated amendment and will be signed by the chair.

5. REQUESTS FOR REVIEW OR MODIFICATION OF THE EXECUTIVE DIRECTOR'S DECISION

- **Lt. Moss- PSCSC NO. 21-05-012 – Case disposition memo to be entered into record**
- **Lt. Rivera- PSCSC NO. 21-05-013- Case disposition memo to be entered into record**

The commission entered into the record a memo and files of the appellants which states:

Because Captain Moss and Captain Rivera have withdrawn their requests for review of the Executive Director's decision, the above referenced cases are closed.

Although the cases did not proceed to review by the Public Safety Civil Service Commission, the Commission affirms the Executive Director's decision and requests that the Executive Director explore potential amendment to the PSCSC Rules to further clarify that certifications will be issued only in the case of an actual vacancy or vacancies at the rank for which the certification is requested.

6. FIREBOAT ENGINEER EXAMS PROTEST APPEAL(S)

- **FF B. Bauer PSCSC No. 21-04-028**

The Commission considered the exam protest appeal filed by Firefighter B. Bauer regarding the Fireboat Engineer Exam held June 16, 2021. Firefighter Bauer addressed the commission on Questions 18 and 122, the subject of the protest appeal.

Yoshiko Grace Matsui, Fire Exams Analyst, Fireboat Engineer Jose Parra, and Chair of the Development Committee Battalion Chief Randy Moser represented the exam development committee. The committee recommended denying question 18 and 122. See section 10. Executive Session for the vote and decision on this item.

7. FIRE AND POLICE EXAM UNIT

Fire and Police Updates-Yoshiko Grace Matsui, Fire Exams Analyst & Rachael Schade, Police Exams Analyst:

- **Fire Update:** Ms. Matsui provided a Fire exam update, reporting that the assessment week for Fire Lieutenant has been completed. There were assessors from other jurisdictions to evaluate 52 candidates who had 2 interviews each. The committee is currently in development for the Fire Engineer practical component. The practical will be held the week of September 13. A memo has been sent to Fire requesting members to apply to be a part of the development committee.
- **Police Update:** Ms. Schade provided a Police exam update, reporting that the Lateral Police Officer oral boards was administered on July 10. Four (4) candidates successfully passed the NTN process, two (2) were invited for oral boards, three (3) of the four (4) passed the oral boards and were placed on the register and are being evaluated by the background investigators. July 19 began training for the captain exams. The first three (3) exam exercises took place. There were nine (9) out of state assessors participating in mock orals and familiarizing themselves with scoring criteria. Seven (7) candidates went through exam process on July 20. The writing

exercise will begin on July 21st, and the remainder of the week will be facilitation of two (2) in person assessments and scoring. The register for this exam will be published on August 27th it will take effect August 29th and will be in effect for two years. Exams for 2022 are currently in development, beginning with the Police Sergeant exams.

- **Honoring SFD Battalion Chief Rick Verlinda:** The commission honored SFD Battalion Chief Rick Verlinda who passed away in June. BC Verlinda served on the fire department for 30 years. He retired from the department in 2013 and continued to serve the city as a consultant on the Fire Promotional Exams. Ms. Scheele read a statement submitted by Colleen Lafferty, former Fire Exams Analyst for the City. Rachael Schade and Amy Emerson honored Battalion Chief Verlinda with remarks. A Resolution was read by Commission Chair Connole on behalf of the PSCSC, Exams Analysts, and the employees of the City of Seattle.

8. EXECUTIVE DIRECTOR REPORT

Departmental Work Update: The Executive Director reported on the following- **Budget:** We are on target for yearly spending. The department submitted change requests for consideration for the 2022 budget. Increases for the salaries to the two positions reclassified in 2020 and increases in available spending for subscriptions were granted. A third full time position for a Strategic Advisor 2 has been requested. No decision has been made on the position request. **Community Service Preference:** Director Scheele reported that an August 18 meeting will be held with the shareholder group on Community Service Preference. A draft for the proposed rule is targeted for October, public comment on the proposed rule will be in November, and ready to adopt in December. Ms. Scheele stated clean up of the rules will also take place during this rule making process. **Work from Home and Return to Work:** Staff continues to work from home and is continuing to track the governor's proclamation on open public meetings.

9. CASE STATUS REPORT

Jones v. SPD-PSCSC No. 20-01-019-Update-Discovery is in progress. The hearing will be held in September.

Crawford-Writ of Review-KCSC-Update-Lt. Crawford filed an appeal with the Washington State Court of Appeals of the Superior Court dismissal of his writ of appeal. Ms. Scheele will provide further information as it becomes available.

10. EXECUTIVE SESSION: The commission went into Executive Session at 10:51 a.m. The Executive Session ended at 11:12 a.m.

- **Fireboat Engineer exam protest appeal (continued from 6):** Commissioner Nark moved to deny the appeal of Firefighter Bauer's appeal for questions 18 and 122. Commissioner Leggett seconded the motion. The motion passed 3-0. The appeal was denied.

11. ADJOURN: All other business before the Commission having been considered, Commission Chair Connole adjourned the meeting at 11:16 a.m.

Dear City Family,

As the initial epicenter of COVID-19, our city workforce embarked upon a monumental endeavor to serve our community. Throughout the past 17 months, we have all had to adapt to a changing “new normal” as we worked together to reduce the spread of COVID-19 in our communities. Our collective work together has led Seattle to be the safest major city in the country with the lowest number of cases, hospitalizations, and deaths.

But our work to protect our families, community, and employees must also match a virus that is constantly evolving. Soon, I’ll be joining Governor Inslee and County Executive Dow Constantine to announce that we will be requiring City of Seattle executive branch employees to be fully vaccinated by October 18, 2021.

Seattle is already leading the country on our vaccination rates: over 82.5% of residents 12 and older have received at least one dose of the vaccine. There is no doubt that vaccines work, and that they are our best defense against the highly contagious Delta variant. In our city and countywide data, we see how vaccines are preventing serious illness, hospitalizations, and deaths even as we have lifted most capacity restrictions at all businesses in the state and more than 60% employees have returned to their work sites.

There has not been a reported death of a Seattle resident since July 11, and Seattle has averaged some of its lowest hospitalizations of the entire pandemic. Of the 1.45 million residents fully vaccinated in King County, 0.1% have had a positive test result following vaccination, 0.004% have been hospitalized for COVID-19 and 0.001% have died due to COVID-19.

The spread of the Delta variant has required that we continue to ensure we are making decisions that our safe for our employees and their families. We cannot forget the basics of keeping ourselves and our families safe: vaccines, testing, distancing and face coverings. With that, I wanted to provide a few updates:

- **Starting Monday, October 18, 2021, City workers will be required to be fully vaccinated as a condition of employment.** This applies to all City workers in executive departments, regardless of whether or not you are reporting to the office, unless you have a religious or medical exemption. Employees will be required to verify and submit proof of vaccination by Monday, October 18. In the coming weeks, we will be creating a new system for verifying employee vaccination status, and we will have more to share on that soon. Employees who applied and are verified to have a medical or religious exemption will be required to undergo COVID-19 testing weekly and be required to distance. All employees will continue to be required to wear face coverings in indoor public settings. [You can find more information in our COVID-19 FAQs.](#)
- **Teleworking employees can continue teleworking through at least mid-October unless**

there is a business need for their return. Over the next two months, the City will be returning employees to reopen public facing counters and community centers and will continue to open library branches. We believe this can be done safely. In addition, teleworking employees can continue to have the option to work from their office. All employees will continue to be required to wear face coverings in indoor public settings. The City will continue issuing the temporary COVID-19 telework allowance and downtown City parking garages will remain \$7 per day.

- **New Alternative Work Arrangements will be available after mid-October, subject to supervisor approval.** We know that while some of you have grown accustomed to teleworking during this time, in-person interactions are important to our work culture and employees' wellbeing by creating opportunities for relationship building, collaboration, and creativity. We must deliver on services for our residents, communities and businesses. Seattle HR will begin rolling out a new AWA process later this week.

Make no mistake, this is the right decision to save lives and protect city workers. Vaccines protect not only vaccinated people but also those who come into contact with them. It is crucial that in our workplaces where we work, eat, have meetings, and laugh together, we make sure we are doing what we can to keep ourselves and our colleagues, our children and families, customers, and members of the public safe from serious illness, hospitalization, or death from this virus. That is why I am implementing this vaccine mandate, and every step of the way, we will continue to make decisions based on the science and public health guidance to save lives.

This has been one of the most consequential times in the history of our City – and every step of the way, City of Seattle employees have been there on the front lines, delivering for our residents and working to keep our communities safe.

As always, thank you for your hard work and dedication to the people of Seattle at a time that is immensely challenging for all of us personally. Continue to take care of one another. We have shown that collective, positive action works.
