

Clean Cities Community Clean Teams Weekly Report

May 20, 2021

Reporting Week May 10 through May 16

Week in Review

This week the community clean team focused on two large emphasis areas including Judkins Park and Gas Works Park, besides the various litter and trash pick-up locations citywide. 20 additional Clean Cities sites were completed by the Parks/SDOT Clean Cities Teams and 29 additional sites were completed by SDOT crews alone. The following summary includes Clean Cities work accomplished by Parks/SDOT Clean Cities Crews.

By the Numbers:

- 260 needles collected
- 117,424 lbs. trash collected via Community Clean Teams
- 16 blocks of litter pickup by SDOT crews
- 187 tents counted onsite
- 19 structures of graffiti removed

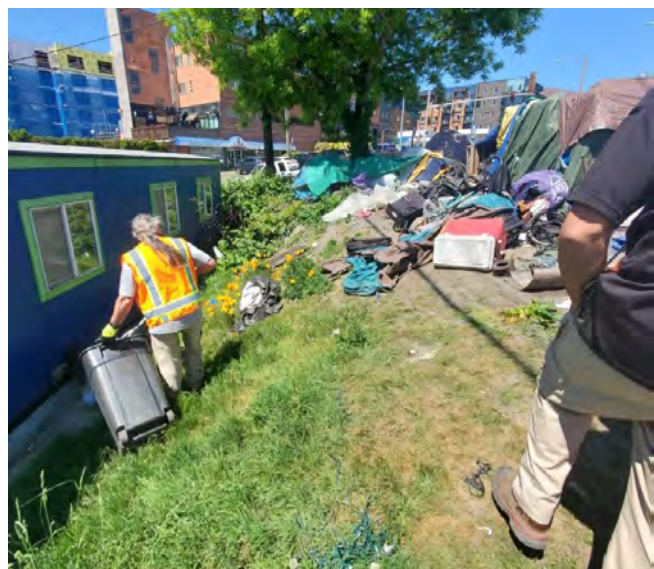

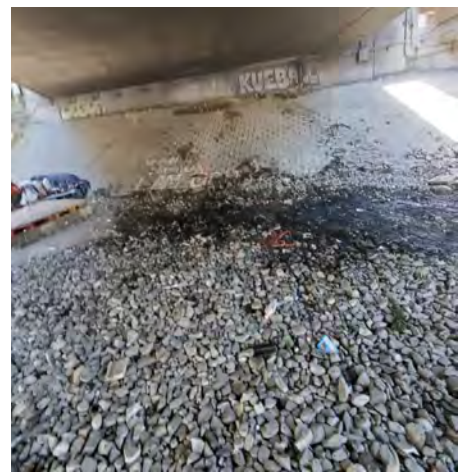

Clean Cities Emphasis Areas

- Judkins Park - 5/11. SC District returned to Judkins Park to continue weeding of beds, digging out blackberry crowns, thistle and other overgrown vegetation on the main bed above the playground. Tree rings were weeded and mulched and weeds in the play area were removed from the engineered wood chips. The curb islands were weeded and mulched and the parking lot, picnic table seating area has been lined trimmed.

- Gas Works Park- 5/13. Staff from NW, CW, SE, and SC supported NE District with their project by sending 1 crew member. The project consisted of mowing, hedge trimming and line trimming in and around the cracking tower. The IMW removed graffiti from the play barn, signs on the tower fencing, and the sundial. The trees in the parking lot were line trimmed and giant hogweed has been removed. Some crew members

line trimmed the slope facing the water and removed blackberry from the plaza seating area. A few staff line trimmed at Waterway 19, 9-Tents on site.

SDOT assisted with blowing leaves, sweeping the parking lot and graffiti removal.

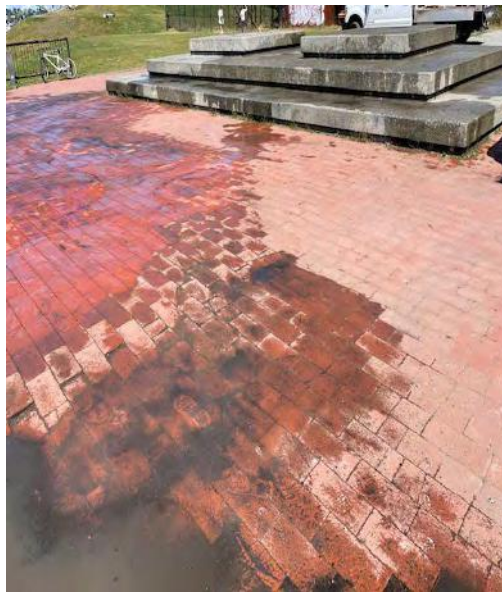
