

Subject: Part 4 question 5 – Hazardous and Problem Waste Analysis

Summary

SDOT has evaluated data from the Ecology Toxic Cleanup database and the City of Seattle GIS in relationship to the proposed project activities and determined that it is contaminated soils and groundwater will not be encountered on this project. In the unlikely event that contaminated soils do appear, SDOT will invoke our robust standards for unexpected discoveries to insure that all soils are handled per State regulations.

The Post Avenue Bridge Replacement Project will remove the existing bridge that supports Post Avenue between Marion and Columbia Streets and replace it with a standard roadway. The project is part of the SDOT Bridge Rehabilitation & Replacement Program and is being funded by the Federal Highway Bridge program. The bridge has a deep timber pile foundation with timber cap beams beneath a concrete bridge deck that has an asphalt overlay. For a portion of the bridge there is a void between the bottom of the bridge deck and the earth of up to 2-3 feet.

During construction the existing bridge deck, timber cap beams will be removed. The soil will be removed to a depth of 6-7 feet below surface. The timber piles will be cut off at approximately one foot below the base of the excavation and the roadbed will be filled with light weight cellular concrete which will act as the base of the restored roadway.

The geotechnical report for the project area states the soils are historic fills to a depth of 27 to 28 feet. The fill was placed between 1880 and 1904 to facilitate the westward expansion of the waterfront and consists of loose to medium dense silty sands to sandy silts. Groundwater level is reported to be 10-11 feet below the surface.

SDOT does not expect to encounter groundwater during construction so we focused our contaminated site review on nearby parcels with contaminated soil. Figure 1 shows the location of the Confirmed and Contaminated Sites in the immediate vicinity of the Post Avenue Bridge. The three closest sites are

None of these sites appear to have contaminated the Post Avenue Bridge project area and SDOT does not expect to encounter contaminated soil during the bridge replacement.

The Seattle Steam Post Avenue site is about one half block south of the project site. Ecology records for the site indicate that fuel tanks are buried 8 to 10 feet deep. Since the project only intends to excavate to a depth of 6 to 7 feet it is unlikely that any of the contaminated soil from the Seattle Steam site will be encountered even if the contamination extends outside the Seattle Steam parcel boundaries. For the Commuter Center the Ecology records state that the only remaining contaminated soil is confined to an area near the building foundation. For the Alexis Hotel the Ecology records indicate that the soil contamination is confined to the area of Post Avenue north of Madison Street, which is one full block north of the project area. For the Butler garage most of the soil had been removed. Finally the Terminal 48 site is a marine sediment cleanup site. Tables 1 and 2 show Confirmed and Suspected Contaminated Sites within a half mile of the project site.

Table 3 lists the Leaking Underground Storage tanks within a half mile radius of the project site. All of the LUST tanks in the immediate vicinity of the project site are part of the Confirmed and Suspected Contaminated Sites discussed in the paragraph above.

Tables 4 and 5 list the regulated and City permitted underground storage tanks within a half mile of the project site. For the regulated tanks the closest operational tank is located at 801 4th Avenue approximately four and a half blocks away from the Post Avenue Bridge construction site. For the City regulated tanks the only active tank is located on Second Avenue between Yesler and James streets, more than three blocks from the project site.


