# WHAT IS SPU?

Seattle Public Utilities (SPU) is a dynamic, forward-looking utility and the largest water supplier in Washington. It provides solid waste, drainage and waste water, for over 650,000 residential and 60,000 business customers in Seattle, as well as 1.4 million drinking water customers in the Puget Sound region. To maintain this infrastructure and level of service, SPU spent \$27.8M in consultant contracts and \$48.3M in purchasing contracts in 2017. As a communitycentered utility, SPU has deepened its commitment to service equity – a concept for ensuring all customers have equitable access and support to fully benefit from our services.
