Request for initiation of formal consultation under ESA section 7, Newhalem Creek Hydroelectric Re: Project (Project No. 2705-037)

Dear Secretary Reese,

Seattle City Light (City Light) filed an Application for Surrender of License for the Newhalem Creek Hydroelectric Project (Project) with the Federal Energy Regulatory Commission (Commission, or FERC) on January 8, 2022. The draft Biological Assessment (BA) was included as Appendix A to the Application for Surrender of License.

As detailed below, based on recent informal consultation with the U.S. Fish and Wildlife Service and National Marine Fisheries Service (Services), City Light requests that the Commission initiate formal consultation under section 7(a)(2) of the Endangered Species Act (ESA) with the Services based on the attached updated April 2025 BA.

On April 16, 2025, City Light provided the Services with a revised BA that had been updated from the previous BA to reflect new "best available science" that, paired with the findings of City Light's 2023 geomorphology report (Newhalem Dam Decommissioning Geomorphology Considerations, Dube 2023), indicates turbidity downstream of the dam will be similar to levels experienced during typical flood events under baseline conditions. Based on this information, City Light revised the recommended effects determinations to "not likely to adversely affect" for all listed fish species, and requested informal consultation and concurrence from the Services.

As the non-federal representative for purposes of informal consultation under ESA Section 7 (designated by FERC July 8, 2021), City Light engaged in discussions with the Services following the delivery of the revised BA on April 16, 2025. Following those conversations and the Services review of the revised BA, the Services determined the project will require formal consultation, to be achieved through the development of condensed biological opinions (see enclosed emails dated July 8, 2025 and July 10, 2025). Thus, City Light is requesting that the Commission, as the federal lead agency, initiate formal consultation with the Services using the attached April 2025 BA. The Services have reviewed this BA and are prepared to develop condensed opinions upon the request to initiate formal consultation. City Light requests the Commission initiate this request with the Services as soon as possible to allow ESA consultation to be completed in the summer of 2025. This timing would accommodate contracting

requirements to allow project decommissioning to commence in the summer of 2026. Considering the on-going landslide concerns along the dam access road, permitting timelines are critical.
