## **SPD Community Engagement Plan**

#### **Workgroup Updates**

**SPD Community Engagement Assessment Workgroup –** The Interim Assessment report on SPD's Community Engagement was sent to the Monitor, Department of Justice and the Seattle City Attorney. The CPC, in partnership with SPD, is working to prioritize themes for the gap analysis that will be conducted to complete the report. The plan for this analysis will be

forwarded to the Monitor and Parties by September 12, 2014. A report of the findings will be submitted to the Monitor and Parties when the analysis is complete.

**Moved, seconded, and passed (10-0-0):** "To approve themes 1, 3, 5, and 8 as priorities for the gap analysis".

**Training Workgroup –** The CPC, in partnership with SPD, will submit a video to be included in the SPD officer training sessions. This will be in addition to a CPC staff and/or commissioner presenting in person at the training sessions.

**Accountability Workgroup –** CPC staff met with Assistant City Attorney, Jennifer Schubert and Otto Klein (Summit Law Group) to discuss the CPCs accountability recommendations. There is a second meeting planned to further discuss the recommendations.

Dr. Melekian has requested that the CPC present him with a description of what it believes the "civilian oversight body" should be.

**Moved, seconded, and passed (9-0-0):** "To approve with ammendments, the letter that will be sent to Dr. Melekian and Scott Lindsay on August 14th regarding the CPC's recommendations for the civilian oversight body for the City of Seattle".
