Continued Conversation about CPC's role in defunding

Conversation about City of Seattle Subpoena of Journalists

Co-Chair updated the Commission on the subpoena filed by SPD to access the journalist's footage on the protests. The Court granted the subpoena, In addition to objections by the community, and three City Council members came out against the subpoena. CPC Staff Jesse Franz outlined possible actions that can be taken in response to the Court's decision. The judge has issued his revised ruling in July giving three weeks before it could be appealed. The Seattle Times plans to appeal. This is the reason CPC Staff is bringing it to the Commission is to have the time to move in the direction the Commission wants within the window for appeals.

The CPC voted to approve to authorize CPC: (1) to request the City to withdraw the subpoena to access journalist's unpublished information; and (2) to speak out against, and to potentially file briefs against, the City's move to subpoena journalists work and information,
