# OLEO Recommendations to King County Sheriff's Office

Deborah Jacobs, executive director of the King County Office of Law Enforcement Oversight, presented its reports of recommendations for the King County Sheriff's Office surrounding the officer-involved shooting of Mi'Chance Dunlap-Gittens. OLEO made 43 recommendations to the Sheriff's Office. The sheriffs' union filed a grievance against OLEO as a result of OLEO's report.

The King County Law and Justice Committee will have a hearing on Tuesday, February 25 at 9:30am continuing to discuss OLEO's report.

# King County Inquest Process Discussion

Jessica Nadelman, Civil Division Chief, and John Schochet, Deputy City Attorney, of the City Attorney's Office discussed the City of Seattle's lawsuit related to inquest reform. The City expressed its concerns on whether the new inquest process went beyond what the state law that governs inquests allows. In early December, Executive Dow Constantine issued a revised version of the Order that stated that officers cannot have counsel unless they testify. This raised constitutional issues for the City Attorney's Office, which is why they decided to take this to Court. The City was concerned from the start about the 2018 Executive Order because it extended what is statutorily allowed. The writ filed by the City addresses the 2018 Executive Order because the City desires clarity on inquest processes.

The Commission considered how to develop a position on surveillance technologies used by law enforcement. It requested that the Police Practices Workgroup develop a draft position for the CPC's review.
