Public Comments

CPC Commissioner Seats (Standing Agenda Item)

The CPC reviewed the status of commissioner seats.

Co-Chair Updates (Standing Agenda Item)

- CPC Updates on current work The CPC Co-Chair reported on the recent work of the CPC. These include the joint recommendation with the Accountability Entities to address the use of tear gas against protestors which includes blast balls. However, the later were used in recent protests. CPC issued its own recommendation to the Mayor and City Council to strengthen Police accountability in being responsive to community demands; The CPC filed a Response Brief to the Court responding to the City's motion which withdrew portions of its sustainment plan that was previously filed. The CPC is waiting to hear on the outcome of the brief; The CPC has historically supported the Inquest process. The City has recently filed a writ to dismantle the process. CPC has requested the City withdraw its writ, which it did so; ACLU and Perkins Coie filed a restraining order with respect to crowd control weapons which was granted by the federal court for 14 days. City Council has passed two ordinances with respect to choke holds and the use of crowd controls weapons used by SPD against demonstrators in recent protests.
- CPC Workflow Log The Co-Chairs discussed the current CPC Work Items and went over a workflow log with the Commissioners. The four main areas in which the CPC will devote time and create sub-committees for are: 1. Strengthening police accountability; 2.

Reviewing the police response to community demonstrations; 3. Defunding the police department; and a 4. State legislative agenda.

 Welcome New Staff - The CPC said goodbye to our last temporary administrative specialist whose temporary assignment has ended. We have a new Temporary Administrative Specialist – Jeannette Martin. We also have a new Policy Director-Shayleen Morris who is joining us on June 24, 2020.
