- Budget presentation by Kara
 - ❖ 11 FTE employee moved to human services for 2020
 - ❖ 2021 reduction bulk: parking enforcement, 911 going independent
 - **❖** Navigation team/deployment: Kara needs to get numbers for reduction
 - ❖ Decrease in revenue 5-10%, received government funding supplemented
 - Even if position is vacant, still included in budget
 - Hired 51 officers in 2020
 - Diversity Strategy?
 - **❖** New Hires more diverse than old officers except older officers
 - ❖ Allocated budget parameters within tiers of service... incentive?
 - Kara: would take restructuring and bargaining. Retirement incentives... conversation points
 - Out of Order Lavoffs?
