VI. Department Updates

- ➤ City Council: Last week there were presentations on a series of department budget and this will continue into next week.
- > Mayor's Office: (Not Present)
- Monitoring Team: Attended SPD's African American Advisory Council Meeting. We also met with DOJ and OIG.
- > Department of Justice (DOJ): No update but we are here if you have questions.
- Office of Inspector General (OIG): On the questions that have been raised so far, we would be happy to meet with CPC leadership to discuss them. IG Judge will hopefully be back by next meeting.

VII. Discussion about recent police shooting investigations, SPD policy updates, and crowd control weapons legislation

- ➤ Question from CPC: OPA recently released its investigation onto the deadly police shooting on February 9th. This shows the officer failed to bring any less lethal tools. The result was a written reprimand. Can you walk us through how you reached that conclusion?
- ➤ The chief would not see this case, the reprimand would be signed off on by assistant chief.
- The officer rushed out of the precinct and left his 40 millimeter weapon in his locker
- ➤ He did violate policy by not having the 40 millimeter weapon
- > OPA looked at comparable cases for disciplinary range
- The officer was responding to shots fired and was trying to hurry due to the nature of the call
- ➤ Question from CPC: Is there a policy matrix that determines the initial decision when it comes to discipline for each case?
- Seattle does not have a policy matrix
- > The city uses past comparable cases to determine discipline
- ➤ The 40 millimeter is not banned due to legislation in Seattle
- Question from CPC: What is SPD doing to strengthen de-escalation policies and practices?
- Our focus is Time, Distance, and Shielding. This allows us to have options and typically a safer outcome
- We are conducting a training that focuses specifically on dealing with people with knives

- We have multiple trainings to try and help move the department forward with a people centered approach
- ➤ Bolo wrap: We are looking to deploy 30 bolo wraps to our Crisis Team as a less lethal weapon option
- > CPC Question: Are there new policies being created around these de-escalation tactics and how does that play into discipline for future cases of misconduct?
- Our policies are now in alignment with HB 1310
- OPA would use the same comparables for de-escalation and force as we would have used prior to the changes
- ➤ With regard to the failure to intervene, that is a new policy. We would not have comps for that, so we would have to create them as we go. The Chief would get to create and set those comps.
- ➤ It would be helpful for the CPC to be able to be involved in some of those trainings. It would give us an opportunity to be able to inform the public about these trainings
- ➤ **CPC Question** What is SPD's progress on the policy changes that came out of the Less Lethal Weapons legislation?
- > SPD is currently working with our legal side to deconflict all of the different legislations
