- Monitoring Team: Primarily looking at Use of Force Data and the City Council Less Lethal Weapons legislation

- Office of Police Accountability (OPA): We released the finding of the Terry Caver shooting case. We divided the case into de-escalation and use of deadly force. Officer violated de-escalation policy. Use of Deadly Force was found lawful because of the risk to the officer's life.
- Office of Inspector General (OIG): Deadline impacts in our office due to short staffing. Working on hiring for 3 positions. OIG will offer technical assistance on legislative bills this year.

- 1. Co-Chair Erin Goodman and La Rond Baker stepped down from the CPC
- 2. Per CPC Bylaws, we will elect new co-chairs to serve the remainder of the term which in until January 2022
- 3. **Slate Proposed:** Douglas Wagoner, Katherine Seibel, and Reverend Harriet Walden
- 4. The slate must have different commissioners from each appointing authority. The current slate only has two appointing authorities, not all three
- 5. The CPC would have to discuss bylaw amendment to change the rules about appointing authorities and then vote to amend in the next CPC meeting
- 6. The steps must be: A commissioner must make a motion to amend the agenda to include a bylaws amendment, then a commissioner must make a motion to amend the bylaws article 4A2A to include and exception for the co-chair nominees when you are filling the balance of a term come from at least two appointing authorities
