## **V. Community Engagement Meeting Debrief: Monitor's Core Assessments**

- **Discussion and Follow-Up of CPC Data Inquiries & SPD Data Validity**
- After the monitor reviewed the four parts of the monitoring plan, there were concerns raised by the community about the data SPD was reporting
- The public has questions related to the missing crisis data
- Community definition of crisis may diverge from what SPD and the Monitor may be reporting
- CPC collected questions and believes that a Special Meeting for community members to ask their questions to the monitor and SPD
- **Seattle Police Department, Brian Maxey**
- What does SPD think about putting officers who do not have proper mental health training dealing with people experiencing a mental health crisis?
- Crisis Response Unit works to reach out to high utilizers who have multiple contacts with SPD
- SPD is trained in Crisis Response and would like to increase the availability of a MHP going with the officer and taking the lead on a call where mental health crises are occurring
- How is the encounter for crisis calls being processed and triaged? What resources would help SPD respond better for Crisis Calls? Based on the disparities identified, what best practices can you improve?
- Can you address the flaws in the data that has been highlighted by community?
- We recently discovered that there were links broken in the data analytics platform and it received as "not specified" 1/3<sup>rd</sup> of our UOF data did not have Race Data identified with it. We were able to identify the issues and fix it within a 48 hour period
