


#### ABOUT US







- Reputation: A safe reputation attracts and keeps customers, ensuring steady growth.




## SAFETY CONCERNS IN THE COMMUNITY


- Increased Crime: Criminals are becoming bolder, targeting businesses even during the day.
- Ineffective Response: Police response times are slow, allowing criminals to escape and causing further damage.
- Security Weaknesses: Some businesses lack security measures like cameras and secure doors, making them easy targets.
- Online Fraud: Fake online stores are scamming customers, hurting businesses financially and eroding trust.
- Knowledge Gap: Business owners, especially immigrants and refugees, need more education on security measures to protect themselves.



#### SAFETY SURVEY FINDINGS

We conducted a survey among business owners, and this were our findings.





## ADDITIONAL SAFETY CONCERN


While a significant number initially rated safety as good, many later confided that their true feelings were different.

- 1. Reluctance to Engage: Hesitation to discuss safety issues in depth.
- 2. Fear of Repercussions: Concerns about being witnesses or involved in investigations.
- 3. Fear of Retaliation: Worry about being targeted by criminals.

#### **Information Sharing:**

Educate more on two-way communication channel to share crime concerns and trends between SIBA and the Commission.

Education: Educate business owners on the different kinds of theft and crime that occur, both digital and live in person. Offer resources to spread awareness

### Security Infrastructure Improvement: Work

together to enhance security infrastructure in the community, such as installing surveillance cameras, improving lighting in public spaces, reinforcing door and window locks and if possible installing panic buttons in businesses that directly alert the police, providing a discreet and immediate way to call for help without the fear of being harmed while makin da call.
