This summer, we are launching LEAP, our 6-week, outdoor recreation summer day camp, intended to develop leadership and team building skills for youth, ages 12-18. While this program is open to everyone in the target age range, it is specifically designed for Black boys who are eligible to receive special education services. In addition to advancing play equity, this programming will support improved academic engagement, college readiness, and career exploration.
