We understand from RFP Section 8 Contract Modifications that the City cannot modify the "mutual indemnification" provision. While we understand that the City will not negotiate a contract allowing for mutual indemnification, can the City confirm that it will consider negotiating the Boilerplate Section While we cannot modify the mutual indemnification provision, DEEL may consider other adjustments to the indemnity provision. If a Consultant seeks to modify the Contract, the Consultant must request that within their Proposal response as taking an "Exception". The Consultant must provide a revised version that shows their proposed alternative contract language. The City is not required to accept such proposed changes. Transmittal Form: "At any time upon the City's request, Agency shall also cause to be timely furnished a copy
of declarations pages and schedules of forms and endorsements. In the event that the City tenders a claim or
lawsuit for defense and indemnity invoking additional insured status, and the insurer either denies the tender
or issues a reservation of rights letter, Agency shall also cause a complete and certified copy of the requested
policy to be timely furnished to the City of Seattle."

No, the insurance language referenced is City of Seattle policy.

Budget and contract type: May DEEL please confirm that this project will be awarded as a fixed price contract with payment upon deliverables? Some of the language in the RFP and Q&A answers suggest that this project may be better suited as a Time & Materials contract, since DEEL requiring that offerors' cost proposals include the estimated hours and cost of labor for each evaluation team member on an hourly basis, and the invoicing requirements in Boilerplate Section 6.1 include employee name, hourly rate, and number of hours worked. Correct, the contract is fixed price, with payment on receipt of deliverables. DEEL asks for an hourly breakdown and anticipated cost of labor for the purposes of transparency about the proposed project budget. Please





disregard the example invoice in the contract boilerplate. A deliverables-based invoice template will be provided at the time of contracting.

Beyond the desired qualifications listed in the RFP, DEEL is not formally seeking other consultant characteristics. The proposal response (see RFP page 9) requires a description of consulting team composition and competencies, in which consultants are asked to describe team member experience and expertise related to the project scope and desired qualifications. If a consultant were to describe features like geographic location or team demographics as supporting evidence of meeting desired qualifications, then these factors would be considered by the review panel. Are there stakeholder engagement bodies that DEEL works with for FCCs and specialized classrooms (e.g., advisory committees)? If so, can you share the composition (role, number) and frequency with which they meet?

Are you able to provide more information about the classroom models for Dual Language Classrooms, SPP Plus Classrooms, and the FCC program (outside of the information provided in the Seattle Preschool Program Manual)? Are there existing assessments that measure fidelity to these models, or is it anticipated that the consultant will development fidelity measurements?

We do not have additional details beyond what is included in the RFP and SPP manual. DEEL plans to collect additional information about the SPP Plus and Dual Language classroom models, including potential fidelity markers, in Q4 of 2023 before this contract is executed. Any specific methods for observing fidelity would be developed by the consultant during the evaluation design phase.

The 2021-2022 Annual Report noted biases with the TSG and WaKIDS child assessment tools. Is there any interest in exploring other assessment tools given these limitations, or does DEEL intend to use these assessments for this process evaluation?

TSG and WaKIDS data will be collected and recorded by DEEL on an annual basis, regardless of the methods used for this process evaluation. As these assessments are used in SPP impact evaluations, we lean toward including insights from these assessments in the process evaluation. However, we welcome proposals to incorporate alternative or supplemental assessments that would improve our understanding of the effectiveness of specialized classrooms and minimize biases.

Are you able to share DEEL's annual and bi-annual family and teacher surveys?

We can share data collection protocols with the selected consultant during the contracting and evaluation design stages. Note that the teacher and family survey content can be customized in 2024 to support this evaluation.

Does DEEL know the extent to which there is overlap of students who receive services between the three specialized classroom settings, such as dual language learners who may have also have an IEP?

The classroom settings are distinct (for example, there are no FCC providers who are Dual Language Initiative or SPP Plus providers). Below are some details that may help address your inquiry:

- Of the children in SPP Plus classrooms with IEPs, 18% have a non-English primary language. Of all children in those classrooms, 26% are multi-lingual learners.
- We are not able to track the IEP status of children who are not part of our inclusion classrooms (none of which are dual language) while they are in preschool. However, we do know that at kindergarten entry, about 8% of children previously enrolled in SPP dual language classrooms have an IEP. The trend is





slightly different for the ASL dual language classroom, where historically about 33% of the Deaf and Hard of Hearing children in the classroom have IEPs.

Do child-level data (e.g., TSG, WaKIDS) and teacher-level data (e.g., demographics, qualifications, teacher survey) include identifiers that would make it possible to link them to classroom-level measures (e.g., CLASS, Soy Bilingüe)?

Yes, child-level and teacher-level data include classroom identifiers.

We see that family survey data is identifiable at the preschool agency level. Could you confirm whether this means they are not identifiable at the classroom level?

Correct, they have not historically been identifiable at the classroom level, primarily for logistical reasons. DEEL does not have a specific preference for in-person services, unless there are feasibility concerns associated with remote data collection. For example, we prefer in-person classroom observations, if applicable. Project management and coordination with DEEL is expected to primarily be conducted virtually.

How flexible are the evaluation questions that will be provided by DEEL at the start of the contract?

DEEL's primary goal in providing evaluation questions to the consultant up-front is to limit the effort and time required to engage with stakeholders and determine the scope of inquiry. DEEL is open to recommended adjustments to evaluation questions during both the design phase and in consultant proposal responses, especially recommended adjustments that add specificity or serve to improve the rigor and actionability of findings. Flexibility will depend on how much the questions impact the evaluation scope.

DEEL is not requiring specific engagement with internal and external stakeholder groups. As part of the proposal process, DEEL expects recommendations from evaluators about ways to engage internal and external stakeholders to support the quality of the evaluation and disseminate findings. Examples of stakeholders include DEEL's Early Learning division leadership, DEEL coaches (coaches directly support SPP teachers with their teaching practice), SPP administrators and teachers. The evaluator will have an opportunity to engage with both Hubs and FCC providers as needed based on the proposed evaluation design. For example, Hubs may be the subject of inquiry in primary data collection, or they may be an outreach partner to facilitate contact with FCC providers. Evaluators are welcome to recommend an engagement approach during the proposal and/or evaluation design process.
