Work Progress

Scopes of work include forming the ecosystem of the reef and other concrete elements of the structure. Looking to pour the tank mid-November then will start the waterproofing process. MEP work will start mid-December and looking to set roof beams after the new year.

The Overlook Walk project is fully mobilized and Merlino is active on the main corridor which resulted in some schedule impact, the target completion date is now January 2024.
