Introduction:

You have applied for, or currently reside in, a rental housing unit that participates in an Affordable Housing Program administered through the City of Seattle's Office of Housing. The Office of Housing requests that participating properties collect race, ethnicity, disability, and age data from all eligible households, using categories predefined by the U.S. Census Bureau. The data provides critical information to policy makers to help ensure equitable access to affordable housing opportunities for all. There is no penalty for those households who do not wish to provide the requested information, however, you must be offered the opportunity to disclose your household's race and ethnicity.

Instructions: Check one or more Race, Ethnicity, and Disability boxes for each household member (HHM) based on how each member self-identifies. Multiple racial categories may be indicated by checking more than one box. Parents/guardians are asked to disclose on behalf of all children in the household who are under the age of 18. All adult household members (18 years or older) must sign/date the bottom of this. For the box titled Age, mark yes or no if anyone in the household meets those age brackets.

Use the following definition for Race:

White: A person having origins in any of the original people of Europe, the Middle East or North Africa.

Black/African American: A person having origins in any of the black racial groups of Africa.

American Indian or Alaska Native: A person having origins in any of the original peoples of North and South America (including Central America), and who maintain tribal affiliation or community attachment.

Asian: a person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.

Native Hawaiian/Other Pacific Islander: A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
