I. The Top Six Scams for 2024

The MCAAE Financial Literacy & Fraud Awareness committee (Paula Williams and Rita Howard) presented information on the top six 2024 scams targeting older adults and how to avoid being duped by them.

Check Cooking Scam

Remember to:

- Avoid the use of paper checks; use credit cards instead.
- Destroy old check stock by shredding or burning.
- Should you continue using checks, drop your payments off inside the post office.
- Monitor your checking account frequently.

What to do if you suspect you've fallen prey to this scam:

- Notify your bank immediately.
- Contact the authorities (police, Federal Trade Commission).

Voice Print Scam

Remember to:

- Be cautious when taking calls from even recognized numbers, as they can be spoofed.
- Better yet, don't answer your phone at all. Let callers leave you a voicemail or send you a text.

What to do if you suspect you have fallen prey to this scam:

• Contact the authorities (police, Federal Trade Commission).

Delayed Action Sweepstakes Scam

Remember:

- If it seems too good to be true, it likely is.
- Never give out personal information (banking information, social security numbers, etc.).





If you suspect you have fallen prey to this scam:

- Contact your bank immediately.
- Contact the authorities (police, Federal Trade Commission).

Virtual Celebrity Scam

Remember:

- If you get a direct message from someone claiming to be a celebrity, they're likely not;
 be skeptical.
- If you get an offer from a celebrity 'manager' to connect you to their client's personal account, don't fall for it. The 'celebrity' at the other end of the line is likely an imposter.
- The wealthy Nigerian prince is likely neither, you're being scammed.

What to do if you believe you have fallen prey to this scam:

- Contact your bank /credit card company immediately.
- Contact the authorities (police, Federal Trade Commission).

Multistage Grandparent Scam

Remember:

- Scammers will provide a case number for the grandparent to reference; they'll tell you to contact your attorney.
- When you call back and reference the number, they know you didn't call your attorney and that you'll be compliant.
- Call or text your grandchild on their regular phone number and see if they really are in trouble. If you can't reach them, contact other family members for verification. Scammers are counting on you to keep this a secret.

What to do whether or not you believe you have been scammed:

- If you have given bank/credit card information, contact your financial institution.
- Contact the authorities (police, Federal Trade Commission).

Paris Olympic Scam

Remember:

- If you get a call from a friend or relative that they have an emergency, be skeptical. Hang up and contact them at their regular phone number for verification.
- You can also try and verify by contacting others who would know whether the person went to Paris for the Olympics.
- If you are purchasing tickets, do so via a reliable, established vendor.
- If you receive communications concerning your Olympic tickets, examine the address carefully and don't—under any circumstance—give out your ticketing account ID and/or password. NEVER give out your banking information.

If you believe you have become a victim of this scam:

- Contact your financial institution.
- Notify the authorities (police and/or Federal Trade Commission).

 - Goal to create more affordable housing options and more housing stock
 - The plan seems to have missed consideration of older adults and needs to consider accessible housing and aging in place
