1.	Application/ Contracting	Can you provide a list of the agencies currently funded?	Lambert House, Northwest Network, Lifelong Aides Alliance, Therapeutic Health Services, South Park Redevelopment Committee, Sea Mar Community Health Center, Neighborhood House, Interim Community Development Association, Associated Recreation Council, Kandelia, Refugee Women’s Alliance, Horn of Africa, El Centro de la Raza, Asian Counseling and Referral Services, Southwest Youth and Family Services, Powerful Voices, Boys and Girls Clubs of King County, YouthCare, Chinese Information & Service Center, Seattle School District, Juma Ventures
2.	Eligibility	Are organizations that are fiscally sponsored by a 501(c)(3) eligible for this funding opportunity?	Organizations without a 501(c)(3) status may use a fiscal sponsor. The fiscal sponsor must meet all of the HSD Agency Minimum Eligibility requirements .
3.	Eligibility	Due to the increased essential worker payments and increase in unemployed clients, many of our clients are no longer low-income per the HUD definition, but are struggling due to high Seattle rental rates. Moreover, not all of our clients will meet HUD's low income definition once the pandemic is over and they are able to go back to work, yet others will be low income due to the \$4 increase in pay ending. How is the RFP going to handle these changing income realities and are we still eligible to apply?	For this RFP, HSD will continue to use HUD income guidelines (80% AMI or lower) for client eligibility. Recent HSD partnerships with the community still reflect a huge need and demand in low income populations needing services and support.
4.	Community Engagement	The City did some focus groups with youth to learn about youth priorities for supportive services and what they want around employment support. Can you share those results?	HSD will compile notes from these focus groups and post them on the HSD Funding Opportunity webpage . Please also reference the Data and Literature Review Highlights for this RFP available on the website.
5.	Budget/Finance	What is the non-profit’s annual revenue amount for which you require an audit?	All applicants will be required to submit most audits, if available, if they have an annual revenue above \$750,000.

6.	Budget/Finance	How much funding is available?	Approximately \$3.7 million
7	Strategy/ Programming	What is your ideal version of ratio for staff to youth?	There is no stipulation of an ideal ratio. Agencies should determine the ratio based on programming, client needs and best practices.
8	Interview	What is the thought process behind the 100% interview scoring system?	The interview is an opportunity for agencies whose strengths might not be in the written process but who have strong oral traditions and can articulate about the work that they do or who do not have access to a grant-writer. The interview is worth 100 points or 50% of the overall score.
9	Interview	Have you chosen an interview panel?	Yes. The panel is made up of community members, other funders and some City staff. We do not release names of panel members until the process is over.
10	Budget/Finance	What is the percentage for administrative and overhead costs?	As a pilot, HSD removed the indirect rate cap for 2021 General Fund contracts but is continuing to evaluate the impact before any formal adoption. It is too early to tell if the removal will apply to contracts beyond 2021. Traditionally, the indirect rate was capped at 15%. Federally approved rates still apply.
11	Strategy/ Programming	To meet the RFP criteria of year-round services, would it be ok to add or offer reduced services throughout the summer?	HSD is looking to fund quality services that are provided throughout the year. If services are reduced in the summer, please ensure that they are with appropriate dosage and high quality to justify funding.
12	Strategy/ Programming	Are there guidelines as to how many youth should be served and an appropriate number of hours spent with the youth?	No, there are no specific guidelines. Submit a program model based on programming, client needs, and best practices.

13	Application/ Contracting	How do I submit my 501(c)(3) letter?	Submit your approved 501(c)(3) letter at the time of the application. If you do not have 501(c)(3) status yourself, please use a fiscal sponsor with a 501(c)(3) status.
14	Rating Panel	Is the RFP rating panel culturally relevant and culturally competent?	Yes, we make every attempt to have a very diverse panel that reflects the focus population of the RFP. Panel members are of different ages, professions, races and ethnicities, etc. and have content expertise.
15	Budget/Finance	Is there an acceptable percentage of the budget that can be allocated to youth stipends?	This RFP does not stipulate the amount of youth stipends. Applicants can propose what is reasonable given the population served and best practice and include in the budget proposal.
16	Budget/Finance	How much will HSD be funding for each agency?	HSD will fund up to 18 agencies. There are no predetermined amounts. Funding awards will be based on the proposals.
17	Interview	Will all agencies that apply be afforded an interview?	Each applicant that submits an application and meets the Agency Minimum Eligibility requirements will have an interview.
18	Interview	How many people from the agency will be allowed in the interview?	Each agency can have up to 4 people in the interview. Interviewees can be staff members, volunteers, a young program participant, etc.
19	Strategy/ Programming	Can volunteers count as a part of programming staff?	Yes. However, please ensure that the quality and ratio is consistent. In addition, volunteers should receive appropriate supervision.
20	Budget/Finance	Has this funding been offered before? If so, how many organizations applied the last time and how many were funded? What is your expectation around the number of applications you will receive?	Yes. HSD currently funds about 20 agencies and about 33 contracts for these services. HSD does not have a good sense of how many applications will be received but does anticipate this being a very competitive process.

22	Strategy/ Programming	Is there a preference for out-of-school youth to be served?	There is no specific preference for serving out-of-school youth. The RFP's priority population is low-income youth of color. Please refer to the Guidelines and Application for its focus populations.
23	Strategy/ Programming	Are principal investigators and co-principal investigators appropriate for a collaborative effort?	It is unclear what roles principal investigators and co-principal investigators will play in your program model but collaboration with partners is encouraged, e.g. bringing in community members, consultants, or partners and paying them to help deliver services.
24	Budget/Finance	Are there any limitations around stipends or support services?	This RFP does not have a limitation around stipends. However, IRS requires Form 1099 to be issued if payments to any individuals are above \$600 in a calendar year. Please see Question #15.
25	Budget/Finance	Is there a maximum cost per youth served?	HSD does not have a maximum cost for per youth served. However, the cost of serving a youth should be in alignment and reasonable to the proposed program model. Please also see Questions #15 and #24.
26	Strategy/ Programming	Do services being provided have to be within the Seattle area or can it be across Washington state?	Services have to occur within the city of Seattle limits. Youth must be Seattle residents, or attending Seattle schools.
27	Strategy/ Programming	Do youth have to be living or attending schools in Seattle?	Yes, however youth experiencing homelessness who may be living outside the Seattle area but attending schools within Seattle school district, or city limits, are still eligible. Please see Question #26.
28	Application/ Contracting	Will you have a compiled Q & A document posted on your website?	Yes.
29	Application/ Contracting	How many programs are currently being funded?	Currently there are about 33 contracts. Please see Question #1 and Question #20.
