2025 Commercial Sexual Exploitation Survivor Services Request for Proposal (RFP)

Closed

HSD intends to invest in resources and coordinated services for survivors impacted by commercial sexual exploitation.

Services may include:

- Community-based advocacy services with flexible client assistance to support individuals impacted by commercial sexual exploitation.
- Emergency shelter/housing services to address the spectrum of needs for individuals impacted by commercial sexual exploitation.

2025 Community Safety Request for Proposal (RFP)

HSD intends to invest in a continuum of services supporting people and communities in Seattle that are directly involved in, and impacted by, gun violence. HSD recognizes that lasting community safety cannot be achieved through a single approach, therefore, this RFP will invest in a service model comprised of the following three strategies:

1. Intervention Services to concentrate services in places and for people involved in the majority of gun violence in Seattle through the following:

- 1a. Hospital-based intervention
- 1b. Intensive individual services
- 1c. Place-based interventions

2. School Safety Services to improve student sense of safety; and

3. **Supportive Services** to provide case management and resource navigation to participants

2025 Farm to Child Care

Expedited Request for Qualification (RFQ)

HSD intends to invest in Washington grown fresh produce for low-income children attending family home child care programs as part of HSD's Child Care Nutrition Program.

Services will include:

- Procuring Washington grown produce.
- Delivering produce and customer service to providers in coordination with HSD staff.
- Providing nutrition education materials.

Funding Available: **Up to \$72,900 for 16-month contract**
