ADEEGSIGA KHIYAANADA AH EE XUQUUQAHA SIYAASADDA

FASAXA MUSHARKA LEH EE QOFKA JIRAN IYO FASAXA BADBAADADA

SHAQAALAH ABLIKEESHINKA KU SALEYSAN WAXAY XAQ U LEEYIHIIN:

- Inay helaan ugu yaraan hal maalin oo ah Fasaxa Musharka Leh Ee Qofka Jiran Iyo Fasaxa Badbaadada (PSST, Paid Sick and Safe Time) ee 30-kii maalmood ee laga shaqeeyo gudaha Seattle
- In maalin kasta oo laga qaado ama la geeyo Seattle ay ku xisaabsadaan qaadashada PSST
- Ogeysiiska billaha ah ee qadarka ururay ee PSST, qadarka la heli karo, la adeegsaday, iyo qiimaha lacag bixinta ee PSST
- In la siiyo celceliska qiimahooda magdhowga maalinlaha ah ee maalin kasta oo PSST ah oo la isticmaalo
- Inay qaataan waqtiga fasaxa ah ee la heli karo ee ka badan 24 saacadood
- Inay marin u heli karaan sistamka si ay awood ugu yeeshaan inay adeegsadaan, fahmaan oo ay codsadaan PSST

WAQTIGA FASAXA EE MUSHARKA LAGU BIXIYO WAXAA LOO ISTICMAALI KARAA SABABAHAAN:

WAQTIGA JIRRADA: Si loola tacaalo xaalad caafimaad oo jireed ama maskaxeed, oo ay ku jiraan ballamaha caafimaadka, ee uu leeyahay qofka laftigiisa ama xubnaha qoyska

WAQTIGA BADBAADADA: Sababaha la xiriira shaqaaqada gudaha qoyska, xadgudub galmo, daba-galka, xiritaanka shaqada ee ku yimid amarka sarkaal caafimaadka dadweynaha ah, marka dugsiga ama goobta daryeelka la xiro, taasoo saameyneysa naftooda ama xubnaha qoyska

XAQA KA HOR IMAANSHAHA MAGDHOW KAHAYSASHADA
