Jon Cracolici determined a quorum was present and called the meeting to order at 4:32 p.m.

091025.1 APPLICATIONS FOR CERTIFICATE OF APPROVAL – DESIGN

091025.11 Ramp, Sidewalk, and Roadway Repair

Right-of-Way: Intersection of 1st Ave and Pike St.

Erik Alvarado, Puget Sound Energy

Proposal for the improvement of a curb ramp, a portion of the surrounding sidewalk, and existing bronze hoofprint inlays at the southwest portion of the intersection. Repair of existing asphalt patches in the roadway. Re-scheduled from the August 13, 2025 meeting.

Staff Report: Minh Chau Le provided exhibits related to the proposal: project description; site plan; photos of existing conditions; construction drawing of ramp; material information for roadway repair, tactile ramp surface, brass inlay replacement information. Additional information: proposal appeared on the MHC meeting agenda of August 13, 2025; John Guay of PSE attended the August 6 DRC meeting. The applicant did not appear on August 13. Relevant guidelines cited 3.1, 3.2, 3.8. Design Review Committee (DRC) recommends further discussion among the full commission.

Jonathan Kiehnau arrived at 4:34 p.m.

DRC: Committee work conducted at the August 6 DRC meeting was reflected in Staff Report.

Applicant Presentation & Comment: Erik Alvarado presented the application, and clarified the amounts of salvageable brick, the commitment to replace hoofprints in-kind, and that re-painting the nearby green pole was not part of the scope of work.

Property Owner Comment: Property owner was not present.

Public Comment: Heather Pihl, Bob Messina.

Commission Questions: Discussion about multiple roadway asphalt patches in the district and replacement bricks that were not an exact match. Confirmation of the curing time for the new pavement, confirmation that around 400-500 new bricks will be used amounting to around 40% of the repair area.

Commission Discussion: No further discussion.

Jonathan Cracolici moved to adopt a resolution approving the application as presented, including the information in the staff report and the testimony given here today and specifying that the tactile domes will be the unpainted version available and also noting that it was estimated that one pallet of new brick will be required for this project. Friendly amendment accepted to perform an inventory of the donor tiles. Seconded by Lisa Martin.

Public Comment: Joan Paulson, Heather Pihl, Bob Messina.

Quarterly item, PDA staff presentation of information and updates: presented by Zack Cook and Katie Trent. Design Advisory Group is actively under way. Historical Commissioner Mark C. Childs participates and will recuse himself from future proposals as needed. PDA will be seeking early guidance from the commission regarding MarketFront Suite F design, Pike St Hill Climb activation, Post Alley seating concepts, MarketFront seating concepts, and the North Arcade slabs. Forthcoming applications for Preliminary Certificate of Approval are the Soames Dunn courtyard and Place Pigalle rooftop addition. Forthcoming applications for Use/Design are the Chef Steps space, Place Pigalle and Pink Door outdoor decks, and temporary pergola bench removal.
