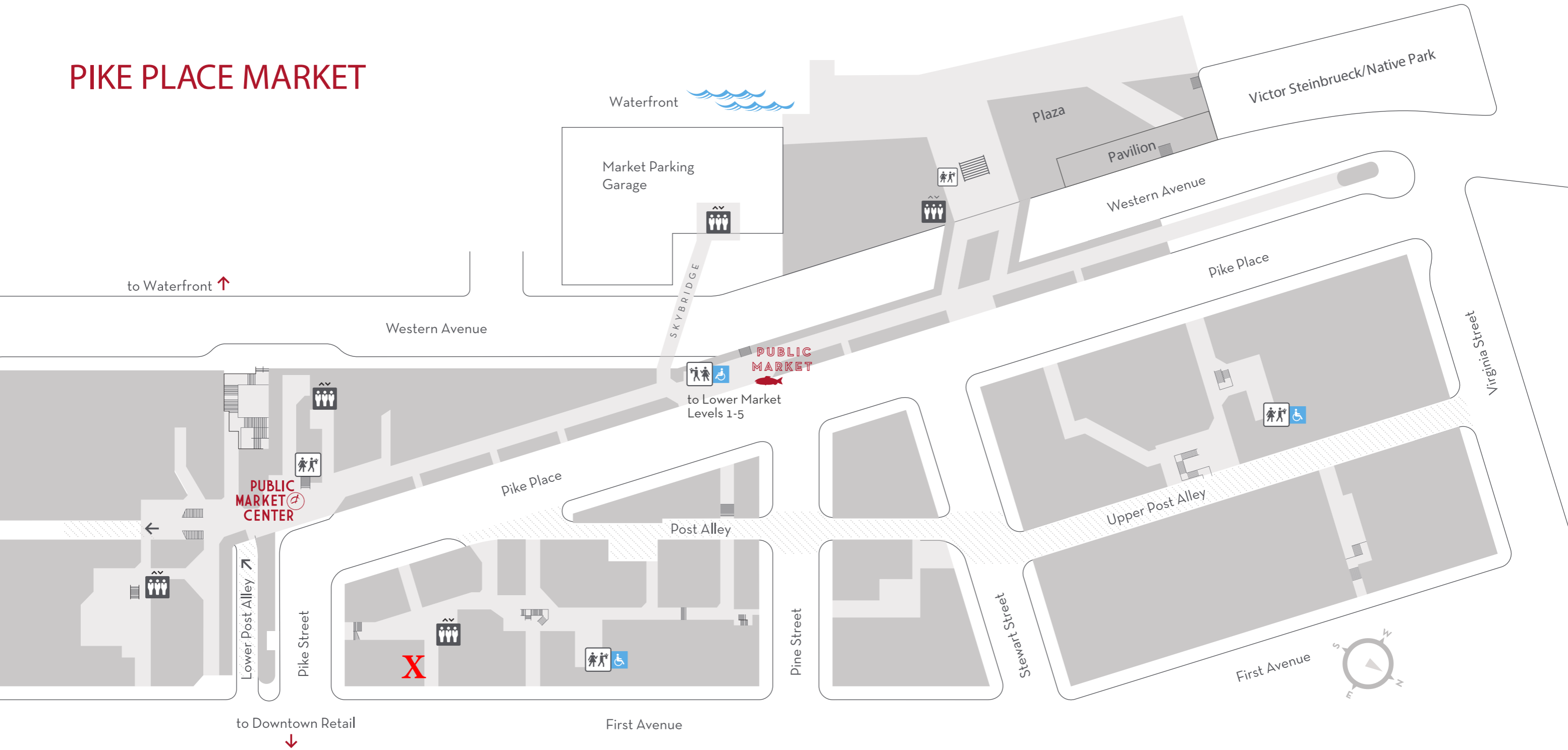
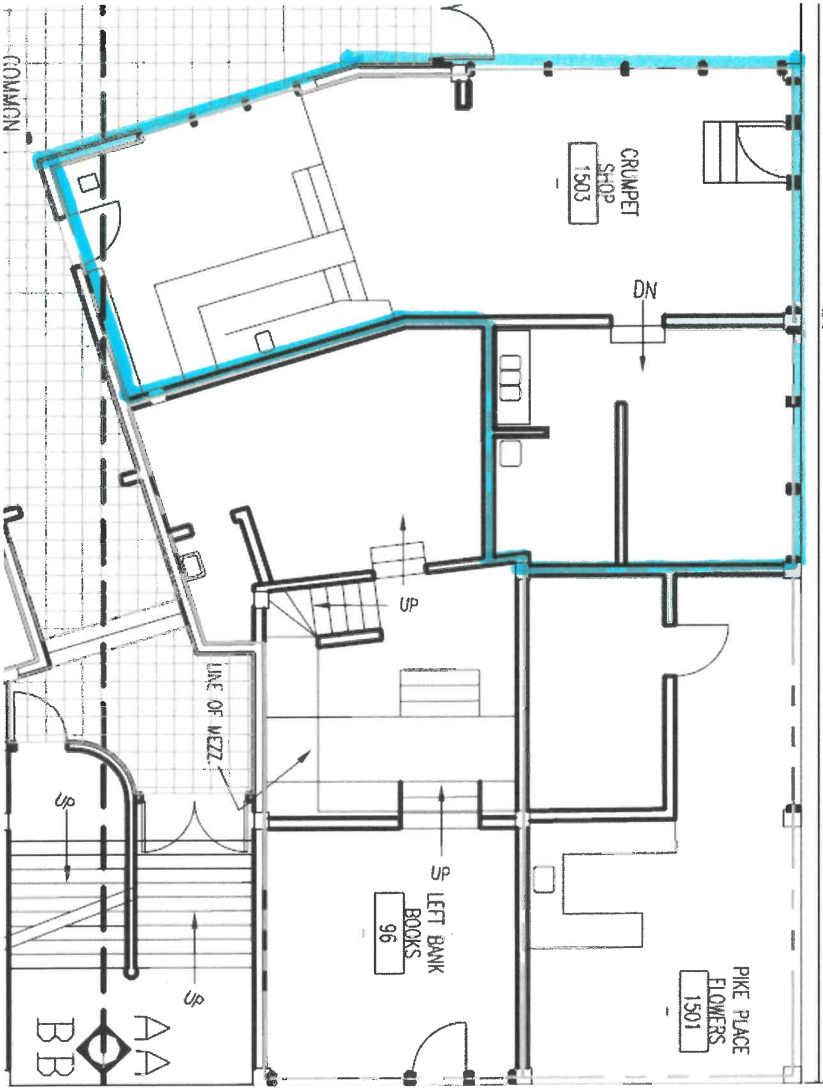

At its meeting of August 22, 1990 the Pike Place Market Historical Commission approved the following:

Expansion of use to allow the continued sale of beverages (including tea, coffee and espresso, soda pop, juices and mineral water) and products complimentary to the crumpet specialty; jams, packaged tea and tea accessories.

Clarification of previous use approvals:

7.15.75 Use as a crumpet baking and retail sales business

10.24.77 Expansion of use to include sale of scones

12.10.87 Expansion of use to sell meat and fish sandwiches using British garnishes, cheeses and condiments; soups characteristically British, British flavors of ice cream and sherbet (raspberry/mint, gooseberry/rosemary, red currant, tea, ginger and brambleberry).
