5	AN ORDINANCE relating to historic preservation; imposing controls upon the University
6	National Bank, a landmark designated by the Landmarks Preservation Board under
7 8	Chapter 25.12 of the Seattle Municipal Code, and adding it to the Table of Historical Landmarks contained in Chapter 25.32 of the Seattle Municipal Code.
9	Eanomarks contained in chapter 25.52 of the Seattle Municipal Code.
10	WHEREAS, the Landmarks Preservation Ordinance, Chapter 25.12 of the Seattle Municipal
11	Code (SMC), establishes a procedure for the designation and preservation of sites,
12	improvements, and objects having historical, cultural, architectural, engineering, or
13	geographic significance; and
14	WHEREAS, the Landmarks Preservation Board ("Board"), after a public meeting on May 19,
15	2021, voted to approve the nomination of the improvement located at 4500-4502
16	University Way NE (which is referred to as the "University National Bank") for
17	designation as a landmark under SMC Chapter 25.12; and
18	WHEREAS, after a public meeting on July 7, 2021, the Board voted to approve the designation
19	of the University National Bank under SMC Chapter 25.12; and
20	WHEREAS, on October 6, 2021, the Board and the University National Bank's owner agreed to
21	controls and incentives to be applied to specific features or characteristics of the
22	designated landmark; and
23	WHEREAS, the Board recommends that the City Council enact a designating ordinance
24	approving the controls and incentives; NOW, THEREFORE,
25	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Erin Doherty DON University National Bank Landmark Designation ORD D1a

1	Section 1. Designation. Under Seattle Municipal Code (SMC) 25.12.660, the designation
2	by the Landmarks Preservation Board ("Board") of the improvement located at 4500-4502
3	University Way NE (which is referred to as the "University National Bank") is acknowledged.
4	A. Legal Description. The University National Bank is located on the property legally
5	described as:
6 7 8 9 10	Lots 16 and 17, Block 1, University Heights, according to the plat thereof recorded in Volume 9 of Plats, Page 41, in King County, Washington; Except that part of said Lot 17 as conveyed to J. W. Taylor and Emma Taylor by deed recorded July 14, 1925 under recording no. 2045590; and Except that portion of Lot 16 lying within the right of way for Northeast 45th Street.
11	B. Specific Features or Characteristics Designated. Under SMC 25.12.660.A.2, the Board
12	designated the following specific features or characteristics of the University National Bank:
13	1. The exterior of the building.
14	C. Basis of Designation. The designation was made because the University National
15	Bank is more than 25 years old; has significant character, interest, or value as a part of the
16	development, heritage, or cultural characteristics of the City, state, or nation; has integrity or the
17	ability to convey its significance; and satisfies the following SMC 25.12.350 provisions:
18	1. It embodies the distinctive visible characteristics of an architectural style, or
19	period, or of a method of construction (SMC 25.12.350.D).
20	2. It is an outstanding work of a designer or builder (SMC 25.12.350.E).
21	3. Because of its prominence of spatial location, contrasts of siting, age, or scale,
22	it is an easily identifiable visual feature of its neighborhood or the City and contributes to the
23	distinctive quality or identity of such neighborhood or the City (SMC 25.12.350.F).
24	Section 2. Controls. The following controls are imposed on the features or characteristics
25	of the University National Bank that were designated by the Board for preservation:

1	A. Certificate of Approval Process.
2	1. Except as provided in subsection 2.A.2 or subsection 2.B of this ordinance, the
3	owner must obtain a Certificate of Approval issued by the Board according to SMC Chapter
4	25.12, or the time for denying a Certificate of Approval must have expired, before the owner
5	may make alterations or significant changes to the features or characteristics of the University
6	National Bank that were designated by the Board for preservation.
7	2. No Certificate of Approval is required for the following:
8	a. Any in-kind maintenance or repairs of the features or characteristics of
9	the University National Bank that were designated by the Board for preservation.
10	b. Installation, removal, or alteration of signage for accessibility
11	compliance, and other signage as required by City code.
12	c. Installation, removal, or alteration of signage, if consistent with a
13	comprehensive signage and graphics plan approved by the Landmarks Preservation Board.
14	d. Installation or removal of interior, temporary window shading devices
15	that are operable and do not obscure the glazing when in the open position.
16	B. City Historic Preservation Officer (CHPO) Approval Process.
17	1. The CHPO may review and approve alterations or significant changes to the
18	features or characteristics listed in subsection 2.B.3 of this ordinance according to the following
19	procedure:
20	a. The owner shall submit to the CHPO a written request for the alterations
21	or significant changes, including applicable drawings or specifications.
22	b. If the CHPO, upon examination of submitted plans and specifications,
23	determines that the alterations or significant changes are consistent with the purposes of SMC

1	Chapter 25.12, the CHPO shall approve the alterations or significant changes without further
2	action by the Board.
3	2. If the CHPO does not approve the alterations or significant changes, the owner
4	may submit revised materials to the CHPO, or apply to the Board for a Certificate of Approval
5	under SMC Chapter 25.12. The CHPO shall transmit a written decision on the owner's request to
6	the owner within 14 days of receipt of the request. Failure of the CHPO to timely transmit a
7	written decision constitutes approval of the request.
8	3. CHPO approval of alterations or significant changes to the features or
9	characteristics of the University National Bank that were designated by the Board for
10	preservation is available for the following:
11	a. The installation, removal, or alteration of ducts, conduits, HVAC vents,
12	grills, pipes, panels, weatherheads, wiring, meters, utility connections, downspouts and gutters,
13	or other similar mechanical, electrical, and telecommunication elements necessary for the normal
14	operation of the building.
15	b. Installation, removal, or alteration of exterior light fixtures, exterior
16	security lighting, and security system equipment.
17	c. Signage other than signage excluded in subsections 2.A.2.b and 2.A.2.c
18	of this ordinance.
19	d. Installation, removal, or alteration of improvements for safety, or
20	accessibility compliance.
21	e. Installation, removal, or alteration of fire and life safety equipment.
22	f. Installation of photovoltaic panels.

1	g. Changes to paint colors for any of the features or characteristics of the
2	landmark that were designated by the Board for preservation.
3	h. Replacement of non-historic doors and windows within original
4	openings, when the Landmarks staff determines that the design intent is consistent with the
5	Secretary of Interior's Standards for Rehabilitation.
6	i. Emergency repairs or measures (including immediate action to secure
7	the area, install temporary equipment, and employ stabilization methods as necessary to protect
8	the public's safety, health, and welfare) to address hazardous conditions with adverse impacts to
9	the building or site as related to a seismic or other unforeseen event. Following such an
10	emergency, the owner shall adhere to the following:
11	1) The owner shall immediately notify the CHPO and document
12	the conditions and actions the owner took.
13	2) If temporary structural supports are necessary, the owner shall
14	make all reasonable efforts to prevent further damage to historic resources.
15	3) The owner shall not remove historic building materials from the
16	site as part of the emergency response.
17	4) In consultation with the CHPO and staff, the owner shall adopt
18	and implement a long-term plan to address any damage through appropriate solutions.
19	Section 3. Incentives. The following incentives are granted on the features or
20	characteristics of the University National Bank that were designated by the Board for
21	preservation:
22	A. Uses not otherwise permitted in a zone may be authorized in a designated landmark by
23	means of an administrative conditional use permit issued under SMC Title 23.

B. Exceptions to certain of the requirements of the Seattle Building Code and the Seattle
 Energy Code, adopted by SMC Chapter 22.101, may be authorized according to the applicable
 provisions.

C. Special tax valuation for historic preservation may be available under chapter 84.26
RCW upon application and compliance with the requirements of that statute.

D. Reduction or waiver, under certain conditions, of minimum accessory off-street
parking requirements for uses permitted in a designated landmark structure may be permitted
under SMC Title 23.

9 Section 4. Enforcement of this ordinance and penalties for its violation are as provided in
10 SMC 25.12.910.

Section 5. The University National Bank is added alphabetically to Section II, Buildings,
 of the Table of Historical Landmarks contained in SMC Chapter 25.32.

Section 6. The City Clerk is directed to record a certified copy of this ordinance with the
King County Recorder's Office, deliver two certified copies to the CHPO, and deliver one copy
to the Director of the Seattle Department of Construction and Inspections. The CHPO is directed
to provide a certified copy of this ordinance to the University National Bank's owner.

3	shall take effect as provided by Seattle Municipal Code Section 1.04.020.
