

The first 18-24 months of the bond program are focused on setting up the foundational elements to support the multiple phases of design and construction.



Key Bond Program Milestones

Since December 2020, King County and Harborview have worked to develop an initial, two-year project plan to drive key early milestones for the project, including

- ✓ An overarching project management structure anchored within the Facilities Management Division of King County
- ✓ Staffing plans for Harborview and King County
- ✓ Budget and financial legislation approvals
- ✓ RFPs for project mgmt. services for schedule and sequencing
- A Bond Program Oversight Committee; and Key Bond Program Stakeholder Groups

ACTIVITIES ON THE HORIZON

- ✓ Planning and sequencing that ensures the hospital's operational needs are met during construction
- Developing predesign elements and identifying site goals and impacts
- ✓ Developing interim parking strategies
- Developing community engagement, project stakeholders and small business outreach plans
- ✓ Working with the Dept. of Neighborhoods to engage the Standing Advisory Committee.
