**Comment**: D. Garg reads the public comment submitted by J. La Vassar who requests the DAC take a public position on SPU proposal of the street and alley vacations on West Bertona. J. La Vassar would like to see a recorded vote by the DAC on whether or not they support the proposals.

**Comment:** D. Garg reads a public comment from Sharon asking how and where has the public hearing been advertised? Has anyone on the Queen Anne community counsel been notified? What are the details of the 8/17/23 hearing? Time, location etc....?
