### MARKAAD KU QAADANAYSO BEERTA BULSHADA WAQTI WANAAGSAN, LAMA OGOLA OO WAA MAMNUUC WAXYAABAHA SOO SOCDA:

While enjoying your community garden, the following are prohibited:

- **BURBURINTA HANTIDA**  
Destruction of property
- **EYDA AAN XARIGA LAGU XIRIN AMA AAN LAYSANKA LAHAYN**  
Unleashed or unlicensed dogs
- **XATOOTYADA DHIRTA IYO HANTIDA**  
Theft of plants or property
- **DHAQAN FOOL-XUN OO LA XARIIRA GALMO**  
Sexual misconduct
- **HAYSASHO, IIBIN IYO ISTICMAALKA MAANDORIYAHA AAN SHARCIGA AHAYN**  
Possession, sale, or use of illegal drugs
- **TUURISTA WAXYAALAHA AAN LOO BAAHNAYN MEEL AAN AHAYN MEELAHA LOOGU TALA GALAY IN LAGU RIDO QASHINKA IYO WAXYAABAHA DIB U WARSHADAYN LAGU SAMAYNAYO.**  
Disposing of unwanted items anywhere but in a designated trash or recycling receptacle
- **HAYSASHADA BUNTUKHYO AMA HUBAB KALE.**  
Possession of firearms or other weapons
- **WIXII AKHLAAQ AH OO SI AAN MACQUUL AHAYN U FARAGALINAYSA ISTICMAALKA AY DADKA KALE ISTICMAALAYAAN MASHRUUCA P-PATCH.**  
Any conduct that unreasonably interferes with other people's use of the P-Patch.
- **DHIBAATAYN AMA KADEEDIS QOF KA MID AH DADWEYNAHA, AMA DADKA BEERTA FALANAYA AMA SHAQAALAHA.**  
Harassment of a member of the public, gardener, or staff.
- **CABIDA CABBITAAN AALKOLO AH RUQSAD LA, AAN.**  
Drinking of alcoholic beverages without a permit
- **CABIDA SIGAARKA**  
Smoking
- **SI XUN U ISTICMAALIDA MEELAHA RAKIBAN EE BIYAHA. (TUSAALE., LAMA OGOLA KU QUBEYSASHO, SHAAMBO KU MAYRID IYO DHAR KU DHAQASHO)**  
Improper use of water fixtures (e.g., no bathing, shampooing, or washing clothes)
- **KU LUG LAHAANSHO DABEECADO CURYAAMIN AH AMA AAN NABAD GELYO AHAYN OO QASAYA DADKA KALE EE BEERTA JOOGA.**  
Engaging in disruptive/ unsafe behavior that disturbs others in the garden
- **KU TUFID CANDHUUF, KU KAADIN AMA KU XAARIS (MARKA LAGA REEBO MEELAHA MUSQULAHA LOOGU TALAGALAY)**  
Spitting, urinating, or defecating (except in designated restroom fixtures)
- **LAMA OGOLA IN LA DEGO (SIDA WAAFAQSAN SHARCIGA MAGAALADA EE NAMBARKIISU YAHAY 18.12.250)**  
No Camping (Seattle City Ordinance 18.12.250)

### FULINTA: JEBINTA SHARCIYADAN WAXAY KEENI KARTAA:

Enforcement: Failure to comply with the rules may result in:

- **IN LOODIIDO QOFKA IN UU SII WADO IN UU KA QAYB QAATO MASHRUUCA P-PATCHKA.**  
Disqualification from further participation in the P-Patch program;
- **KA XAYUUBINTA RUQSADA INUU JOOGO BEERTA MUDO GO, AN.**  
Withdrawal of permission to remain on the property for a specified period of time;
- **QOFKII KASTA EE GALA AMA SII JOOGA BEERTA KA DIB MARKA LOO SHEEGAY IN OGOLAANSHIHII U OGOLAANAYAY IN AY BEERTA SII JOOGAAN LAGA XAYUUBIYAY WUXUU HALIS U YAHAY IN TIGID LA SIIYO AMA LOO XIRO DAMBIGA AH GELID DHUL DADOW AMAR LA'AAN SIDA WAAFAQSAN SHARCIGA MAGAALADA SIYAATAL 12A.08.040**
