

- Staff called attention to the links to required trainings for all city boards and commission members and urged anyone who hasn't already taken these trainings to please do so. Guest speakers available on any of these training topics should anyone be interested in having them attend a future SRC meeting.
- Commissioners expressed frustration over the length of time it has taken to have SRC appointments appear on the Seattle City Council committee agenda. Kate asked if there was an update about the pending appointments. Department of Neighborhoods has not heard any updates on appointments.

Staff suggested revising a few sections, as shown on the highlighted document.

• MOTION by Kate Rubin to amend the bylaws as suggested by staff. Dan Godfrey seconded. Motion passed.

#### Co-chairs review and possible action

- MOTION by Julissa to appoint Kate as temporary co-chair; Dan seconded. Motion carried.
- MOTION by Kate to appoint Lydia Felty as temporary co-chair; Julissa seconded. Motion carried.

### Member updates

- Dan provided an update on the Seattle Social Housing Developer Board. The SRC is
  responsible for some appointments and commissioners should be using the DON email
  address for these communications. Kate asked if Dan was willing to reach out to
  whoever was qualified to ask if they were still interested in being appointed. Dan
  agreed to do so. Dan will share the responses with commissioners to have a vote at the
  next SRC meeting. Kate suggested that in his email, Dan ask if anyone expressing
  interest would like to meet with commissioners. Dan liked the application portal idea
  posed by Lydia Felty, saying it could help staff the work group if it was open soon. Lydia
  Felty said there would be value in figuring out the processes now rather than waiting.
  Kate suggested this be added to the work plan, and in theory people could use the
  portal to start the application process for joining the SRC. Staff advised they can help
  review and provide feedback around data collection as the city is concerned with not
  violating privacy standards by only collecting needed data because of retention laws.
- Kate reported on an issue from the Action Network a King County Councilmember had put forward a motion that would restrict access to right to counsel. Kate agreed to share this information with commissioners.
