Can the SRC have enforcement powers?

Follow-up answer from City Attorney's office:

The Commission is established for the purpose of advising the Mayor and Council on tenants' rights issues and concerns. SMC 3.65.010. Its specific duties are listed in SMC 3.65.040. Those listed duties include to "[m]onitor the enforcement and effectiveness of legislation related to renters and renter protections" and provide "periodic advice" related to enforcement which tracks the bylaws. Thus, the Commission does not have any inherent "enforcement" powers that would be distinct from "monitoring" the enforcement of legislation and reporting back to the Mayor and Council as part of its overall advisory duties.
