Meeting Notes

M. Batayola, S. Valentine, & D. Banerjee GNDOB Co-Chairs, Sara Cubillos, OSE Climate Justice Advisor facilitated the meeting. Lylianna Allala, OSE Climate Justice Director, took notes.

Welcomes and Introductions

Syris Valentine called the meeting to order and provided a land acknowledgement.

Presentations

Update on current version of the Building Emissions Performance Standard (BEPS) policy, Sandra Mallory, OSE

- This is the biggest action the City of Seattle can take to reduce emissions to get us a large reduction in emissions. This would be 27% emissions reduction in the building sector by 2050.
- June 2023 anticipates the policy going to Council
- Broad outreach was done to inform this policy development which included engagement with a
 BEPS Technical Advisory group, mailing list of 4,000 building owners, met with labor
 representatives, non-profit owners, Housing Development Consortium that had their own
 technical advisory group, public meetings, all informed the development of this policy.
- Long runway with a deadline of 2050 that considers the needs of building owners and support programs for under resourced building owners
- Building owners have options to get towards emissions neutral
- In 2022 a support program for under resourced building owners was launched with an initial cohort of building owners. In 2023, a consultant will work with more building owners with a prioritization of non-profits and buildings that serve BIPOC
- 150-270 jobs created by this policy

- Alternative compliance payment option is only through 2035. Revenue will go into financial assistance for under resourced buildings as well as funds from any fines or penalties.
- Multi-family buildings: extend timeline for compliance Affordable multifamily: an even longer timeline for compliance Includes regulated low income housing and lower rent market rate housing
- There is a hardship compliance plan to accommodate extenuating circumstances which can include seismic upgrades and more
- Policy is going through refinement currently, will not go through the SEPA process until April and legislation with Council in June followed by rulemaking.

- A: City is instituting an energy reporting system and the State has a energy use reporting system. City is working closely with the state on a common reporting form.
- Q: Will City of Seattle make energy data transparent to the public on energy usage regarding the Building Energy Performance Standard?

- Q: What are the concerns from building owners?
 - A: Primarily the cost.

- Recommendations outlined in the letter:
 - Increase Alternative Compliance Payment with the true cost of carbon
 - Require all publicly owned buildings covered by the policy to achieve net-zero emissions by 2030.
 - Require all privately owned buildings covered by the policy to achieve net-zero emissions by 2035, with targeted exemptions to meet the unique needs of hospitals and affordable housing.
 - Increase ACP to align with the social cost of carbon defined in the best peerreviewed science available
 - Specify a minimum percentage of the revenues generated to be allocated to programs directly supporting building decarbonization in environmental justice communities.
 - Reconsider use of renewable natural gas as a fuel option
- Syris has sent the draft letter to the board via email for review

Discussion

- Strongly oppose use of fracked gas which is being equated to renewable natural gas
- Would like to hear more about potential increase of the payroll expense tax to create additional revenue to support the BEPS.
- Would like to advocate for the board to think about ensuring a just transition for workers that may be impacted by this policy. Encouragement to have a conversation with workers and union representatives impacted by this policy.
- Comments can be submitted now up until April during SEPA
- Comments can be submitted to City Council in June
- Next steps: Encourage board members to submit comments and edits to Syris and Jess on this letter. Maria will support. Connect with labor representatives on the board regarding conversation needed to have with fossil fuels workers. Keith can raise this with union partners to weigh in on this letter.
