Retreat Update

- Schedules aren't aligning to hold a retreat in April/early May
- Staff will work with the PPP Committee to find alternative ways to solicit in-depth Board member feedback on draft recommendations
- Staff will work with the Executive Committee to onboard new Board members in the interim
- Could still do a Board retreat this summer

Pillar:

Craft a problem statement, tell your story, make a case for the GND pillars

GND Pillars

- •Eliminate pollution
- •Low-carbon, equitable economy
- •Healthy, resilient communities

Budget Recommendation Framework

The What

Theme:

Provide a broad solution

Get more specific...

The Where, Who, When & more of the What

Important Notes:

- This isn't a linear process. For example, you may jump from a specific recommendation, to a pillar, and down to an intervention.
- You may find that you only need to state your pillars/tell your story once or at select points in your recommendations.

solve the problem?

- Not every rec needs to align directly to one pillar; many recs may align with multiple pillars.
- The PPP Comm may use the Criteria for GNDOB budget recommendations later in the process to refine promising recs.

Current <u>DRAFT</u> themes/priorities (PPP Comm/Board to continue to refine)

- Workforce development: jobs
- •Economic development: creating a new market sector
- •Climate resilience: protecting our city from heat, smoke, etc.
- Environmental Justice: pollution elimination & redressing harm
- Leveraging federal & state dollars for green/clean infrastructure: green power & decarbonization

Specific recommendation:

State a clear investment

Intervention or mechanism:

Identify best path(s) to achieve the solution.

- Capital project
- Maintain funding
- Study

Draft Budget Recommendation Themes

- Workforce development: Ensure that there is sufficient supply of welltrained workers in high-road jobs needed to achieve GND goals, and that new career opportunities are focused on BIPOC communities and those under-represented in the workforce today.
- Economic development: TBD
- Climate resilience: Invest in programs that ensure that within 5 years all residents of Seattle have access to healthy and safe spaces during climate-related weather events and other natural disasters.
- Environmental Justice: Use the WA State Health Disparities Map and other tools ensure that investments in programs are focused on pollution elimination & redressing harm in these areas to eliminate these inequities by 2035.
- Leveraging federal & state dollars for green/clean infrastructure: Invest City funds to maximize the potential contributions from the Federal and State governments for investments in the Green New Deal for Seattle



City Budget Basics

- The City has a biennial budget
 - 2025-2026 budget development occurs in 2024



- Available City resources are based on economic forecasts
 - Projected City revenue dictates
 the amount that can be budgeted
 - City is legally required to balance budget.




Typical Budget Process Timeline

Seattle Revenues

Sources	Amount in 2023 (based on 2023 Adopted Budget)	
General Fund (taxes and fees)	\$1.6 billion	
SPU (utility rates and wholesale revenues)	\$1.4 billion	
City Light (utility rates and wholesale revenues)	\$1.5 billion	
SDOT (non-General Fund)	\$560 million	
Voter-approved levies and Parks District	\$410 million	
Other restricted sources (e.g., permit fees, user fees, dedicated taxes, grants)	\$1.9 billion	
Total City Revenues	\$7.4 billion
