Opposed: None.

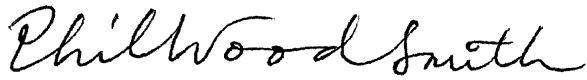
The President signed the Resolution.

There being no further business to come before the Seattle Park District Board, the meeting was adjourned at 4:27 p.m.

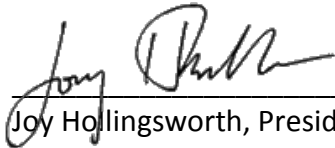
