### Pickleball Proposal – MPAC Action Planning

King provides overview of MPAC communication with SPR since December 2024, and an update on developments to the proposed pickleball project at Magnuson Park.

MPAC members discuss whether to amend and resend the advocacy letter to SPR from December, to incorporate MPAC comments into SEIS feedback, or another avenue. Suggestions include: requesting an extension to the SEIS comment period and participation at BPRC and City Council public comment.

King confirms with members that MPAC's primary goal is to move the project away from its planned location to another location farther from the wetlands.

The area will be restored with grass. A new restroom is scheduled to be started near the main (Jr. League) play area sometime in 2026.
	SPD emphasis patrols in Magnuson park Thu-Sun evenings at the time the park gates are locked. Began May 23.
	With the new 6am-10pm hours for the Boat Ramp and Beach areas there have been several lock-in incidents reported that involved more than one car. Signage is being worked on and we've updated the park hours on our website and removed them from Google. Google is the reported highest use resource for things like operating hours, so we've removed the hours altogether in order to push users toward the website for actual hours. There's also a large electronic sign right now announcing the gate closures.
