As an employee who is exempt from the Civil Service System, you may elect to become a member of the Seattle City Employees' Retirement System. Enrollment in Seattle City Employees' Retirement System is optional for exempt employees. You may elect membership at any time during your employment with the City. If you elect to become a member, the election is **irrevocable**; you cannot reverse that decision in the future.

If you have not worked for the City of Seattle before January 1, 2017, you will be enrolled in SCERS Plan 2 and will not have an opportunity to enroll in SCERS Plan 1.

If you have worked for the City as an exempt employee prior to January 1, 2017 and have not had a break in service, you will be enrolled in SCERS Plan 1 and will retain the right to purchase or redeposit funds for retirement service credit in SCERS Plan 1 after electing to join SCERS. However, if you wish to instead join SCERS Plan 2, you must complete and submit a *SCERS Plan 2 Notice and Election Form* within 60 days of your SCERS Plan 1 membership date. If you elect to join SCERS Plan 2, you permanently forfeit the right to purchase or redeposit funds for prior SCERS Plan 1 service credit.
