NOTICE OF PROPOSED JOINT SDOT/OPCD DIRECTOR'S RULE AND SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)

Pursuant to SMC 25.05.340 and WAC 197-11-340

The Directors of the Seattle Department of Transportation (SDOT) and the Seattle Office of Planning and Community Development (OPCD) propose the following Director's Rule:

Joint SDOT/OPCD Director's Rule: West Seattle Light Rail Station Area Street Concept Plan

The Director's Rule (DR) proposes these street concepts to inform reviews and decision-making about public right-of-way improvements around three planned Sound Transit light rail facilities in the West Seattle neighborhood of Seattle. DRs are authorized in Seattle Municipal Code (SMC) Ch. 3.14.992 and 3.12.020. This DR provides guidelines for the design of future pedestrian, vehicle, and multimodal transportation infrastructure in the right-of-way, with stated goals of expanding public space, expressing community character and history, providing safer environments for people moving through the neighborhoods around the future light rail stations, and improving connections for people walking, biking, and taking transit. In general, the DR provides guidance around improving safety and accessibility for pedestrians, traffic calming measures, adjusting streets to support changing traffic patterns as vehicles access the planned light rail stations, and facilitating ease of transfer between light rail and other modes of transportation. SDOT and OPCD will assign a DR number when the rule is finalized.

LOCATION OF PROPOSAL

The Director's Rule on West Seattle Light Rail Station Area Street Concept Plan applies to the public rights-of-way surrounding the three Sound Transit light rail facilities planned for construction in the West Seattle neighborhood of Seattle. The nearest intersection to each facility is provided here, and full details of the street segments considered under this street concept proposal are provided in the DR and supporting SEPA checklist.

- Delridge Station: Adjacent to 26th Ave SW and SW Andover St intersection
- Avalon Station: Adjacent to SW Avalon Way and Fauntleroy Way SW intersection
- Alaska Junction Station: Adjacent to SW Alaska St and 41st Ave SW intersection

ENVIRONMENTAL DETERMINATION

After review of a completed environmental checklist and other information on file, the Seattle Department of Transportation (SDOT) and the Seattle Office of Planning and Community Development (OPCD) have determined that this proposal will not have a probable significant adverse environmental impact, and have issued a Determination of Non-Significance (DNS) under the State Environmental Policy Act. An environmental impact statement (EIS) is not required under Revised Code of Washington (RCW) 43.21C.030(2)(c). Appeals should be addressed to the Hearing Examiner and must be accompanied by an \$85 filing fee in a check payable to the City of Seattle. The appeal must be sent to:
