Sound Transit Bike Code Amendment Proposal

- Team from SDOT, Sound Transit, & SDCI presented on bike parking related code requirements for new Sound Transit light rail stations in Seattle
 - Divides stations into typologies with different requirements for each: terminus stations, local stations, mid-center stations, and central stations
 - Based on data and survey of bicyclists using light rail
 - Acknowledges that many people will continue to bring bikes onto trains for a variety of reasons, mostly because they need them on the other end of the trip
- Board asked questions about geofencing for micromobility, assumptions used, accommodating larger bikes (e.g. cargo bikes), integrating bike parking card with Orca card, and improved bike cages

Transportation Equity Framework (TEF) Update
