

 - Lynnwood City Center
 - NE 130th Street (2026)
- Route 522 / ST Stride S3 Bus Rapid Transit
- Community Transit also has an approved 2024 Network Redesign plan, which includes extending Swift Blue Line to Shoreline North/185th Station





Phase 3 Service Proposal highlights

- Link light rail will provide very frequent north-south service allowing for new and more east-west bus service that does not exist today.
- Maintaining or improving convenient transit access for Equity Priority Areas and priority populations, including Linden Ave and in the Lake City neighborhood.
- Maintaining or creating new connections to schools and community destinations, especially in Seattle and Shoreline.
- Continuing to shift toward an all-day frequent network that includes more evening and weekend bus service, and less peak-only service.
- A new, <u>Metro Flex on-demand</u> service area in north Kenmore and Lake Forest Park that connects to the Mountlake Terrace Link light rail station.





Route 522 BRT: Bothell to Roosevelt Station (2024)

What you should know:

Route 522 currently connects to the 1 Line at Roosevelt Station.

There are no proposed changes to ST Express Route 522 in 2024. Sound Transit is recommending that changes to Route 522 wait until the full 2 Line is open in 2025.

When the full 2 Line extends to Lynnwood, Route 522 will be revised to connect to the 1 and 2 Lines at Shoreline South/148th Station. Moving the connection north to Shoreline South/148th Station is consistent with future <u>Stride</u> <u>S3</u> Line service.

Sound Transit will continue to work closely with King County Metro to plan local service for stops south of 145th Street through the <u>Lynnwood Link Connections</u> project.

Route 522 will be replaced in a few years by Sound Transit's new Stride S3 Line. The Stride S3 opening date is still under review.







What you should know:

Route 522 currently connects to the 1 Line at Roosevelt Station.

There are no proposed changes to ST Express Route 522 in 2024. Sound Transit is recommending that changes to Route 522 wait until the full 2 Line is open in 2025.

When the full 2 Line extends to Lynnwood, Route 522 will be revised to connect to the 1 and 2 Lines at Shoreline South/148th Station. Moving the connection north to Shoreline South/148th Station is consistent with future <u>Stride</u> <u>S3</u> Line service.

Sound Transit will continue to work closely with King County Metro to plan local service for stops south of 145th Street through the Lynnwood Link Connections project.

Route 522 will be replaced in a few years by Sound Transit's new Stride S3 Line. The Stride S3 opening date is still under review.
