1. Welcome and Introductions

2. Public Comment

Don Brubeck of the Seattle Bike Advisory Board voiced his support for an SDOT proposed solution regarding the separation of bicycles and pedestrians along the E Marginal Way corridor

4. Announcements & Chair's Report

The Move Seattle main committee will be reviewing data and breaking into two subcommittees with the chairman of Move Seattle heading both subcommittees.
