

Greenwood Sidewalks

CONSTRUCTION NOTICE

#### **OVERVIEW**

As soon as \*Monday, March 28 crews will begin installing new sidewalks along both sides of Greenwood Ave N between N 117th St and N 125th St. These new sidewalks are the first phase of our sidewalk project along Greenwood Ave N that will complete the critical gap in pedestrian infrastructure between N 117th St and N 130th St by 2023.

Included with sidewalk construction, we will be performing spot natural drainage treatments, which will enhance water quality and drainage. These improvements will help connect residents to transit and community destinations while working to achieve Seattle's Vision Zero goal to end all traffic deaths and serious injuries by 2030.

### **SCHEDULE AND IMPACTS**

Construction will begin on the east side of Greenwood Ave N at N 125th St and will progress southward to 117th St. Once the east side is complete, crews will switch over to the west side and work their way back north to 125th. Normal working hours will occur Monday through Friday, 7 AM to 5 PM, with the potential for nighttime and weekend work as necessary. This work is the first phase in completing the sidewalk network and will be continued through an upcoming Safe Routes to School project in 2023. Construction is expected to last 6-8 months and is weather dependent. Streets in construction will be allowed local access only and intersections at the end of each block may be closed with detours provided. Parking will be temporarily restricted, and crews will place "No Parking" signs 72 hours in advance. Access to businesses and homes will be maintained at all times during this work, but driveway access will be temporarily restricted; we'll notify you individually ahead of time of potential impacts.

## WHAT TO EXPECT DURING CONSTRUCTION

- Sidewalk and curb ramp construction
- Traffic lanes and sidewalks may be reduced or detoured where necessary
- Typical work hours between 7 AM and 5 PM Monday through Friday
- Local access only on your street
- Detours for intersection closures
- Temporary parking restrictions
- Temporary pedestrian and bike detours around the work zone and staging area
- Access to businesses and homes will be maintained at all times
- Typical construction noise, dust, and vibrations
- Driveways may be temporarily blocked.
  Businesses and residents will be notified of any driveway closures at least 48 hours in advance.
- SDOT is doing some driveway work as part of this project. If your driveway is affected, SDOT has contacted you.

\*There is an ongoing general strike of concrete drivers and concrete plant workers in the Seattle area that involves companies that supply us with concrete for our many active construction projects.
