

Lake City Way NE Transportation Improvements

CONSTRUCTION NOTICE

As soon as **Monday, November 14** work will begin along both sides of Lake City Way NE between 30th Ave NE and NE 125th St. This project will improve bus stops and sidewalks for better transit reliability and pedestrian accessibility.

Upcoming weekend closure

Both Northbound lanes of Lake City Way NE will be closed for weekend work starting November 18 at 7 PM, and will reopen by 5 AM on November 21. Uniformed peace officers will be on site for the duration of the closures to facilitate the detour onto westbound NE 125th St for northbound traffic on Lake City Way NE. Pedestrian detours will be located at the north crosswalk of the intersection of 125th and Lake City Way. Follow detour signage on site. This work is weather dependent and could be postponed if the forecast isn't favorable. PROJECT BACKGROUND

In 2018, the southbound bus stop on Lake City Way at NE 125th St was expanded to give access to two buses at the same time. Now, SDOT will improve the bus stops along the northbound route for better transit and pedestrian accessibility.

PROJECT ELEMENTS INCLUDE:

- New in-lane bus stop and widened sidewalk at the NE corner of LCW & 125th
- Sidewalk repairs on both sides of Lake City Way NE from the intersection of NE 125th St south to the mid-block crosswalk
- Moving bus stops closer to NE 125th St
- · Adding new pedestrian lighting
- Adding facilities for new bus shelters
- Removing 6-8 one-hour parking spots along the east side of Lake City Way

Work is scheduled to begin mid-November 2022 and to be complete in February 2023.

- Typical construction hours: weekdays, 7 AM to 5 PM, with occasional weekend and night work
- Driveway impacts
- Noise and vibration
- Street and/or lane closures
- · Dust and debris
- Construction staging and parking impacts near the work sites
- Crosswalk and sidewalk closures, and detours for people walking and biking
- Access to businesses will be maintained at all times
