We also want to better understand how to support you in these efforts. The information we gather will help shape our <u>Waste Prevention Strategic Plan</u>. This plan will define meaningful waste prevention goals, SPU's role in waste prevention, and how to measure success.

Saving customers money

Buying only what you need, buying second hand, sharing, and repairing broken items are great ways to save money.

Creating new economic opportunities

Waste prevention stimulates innovation. From reuse to repair and remanufacturing to sharing, waste prevention can inspire new types of businesses, services, and employment opportunities.

Building healthier communities

By preventing waste, your business will use fewer natural resources, reduce greenhouse gas emissions, and minimize pollution—paving the way for a healthier community, region, and planet. Everybody can benefit from your actions!

How are businesses like yours preventing waste?

- Making waste prevention a priority across departments
- Cutting back on the amount of material you use to package and ship products
- Purchasing items that will last longer and not have to be replaced as often
- Buying uniforms that can be reused and donated
- Designing and making products that last longer
- Donating or reselling used or surplus items
- Providing bulk sections for customers to refill products
- Using dynamic pricing to discount food nearing its expiration date
- Encouraging customers to use reusable bags and containers
