Long Haul Disposal Contract

- WM provides the rail containers.
- The transfer station does heavy hauling of garbage to Argo and organics to Cedar Grove.

Recycling Contract

- The city contracts directly for recycle, paying a part time processing fee and receiving a credit for the value.
 - This approach is different from suburban jurisdictions but similar to larger cities. Smaller cities bundle services and one of the haulers handles collection, negotiation, and disposal.

RFP Phase

- Questions were sent to the community and answers were received from vendors in the
 recycling industry (MRFs, manufacturing equipment manufacturers). Questions
 included: auditing of material, commodities to introduce, technology in a MRF, recovery
 rate for materials.
- The RFI and answers are public. The RFP (request for proposals) was prepared based upon the RFI responses.
- The evaluation/selection process will end October 31st. Contract signing and approval will include negotiations.
- A year of service preparation will be offered before the contract goes live in 2027.

Union Pacific and Glass

- Union Pacific now transports a lot of glass to California, offering flexibility.
- The new contract needs to allow for adjustments due to new technologies or market changes.

Upcoming Contracts

- A disposal contract is coming up in 2028, and a collections contract in 2029, with potential extensions up to 2033.
- SPU wants to define the requirements for the next disposal and collections contracts. The goal is to create contracts that meet Seattle's needs, are competitive in rates, and environmentally sound.
- Assessments include baseline assessment, benchmarking, options analysis, and recommendations.

Barging and Landfills

- Barging is a potential option for disposal due to landfill limitations. Many municipalities have their own landfills, but these have completion dates.
- King County is trying to extend the life of its landfill, but new landfills are unlikely. Once landfills reach their limit, the only option is train transport.
- Waste Connections is considering building barges to transport waste to a landfill across the Columbia River Gorge in Oregon.

Glass Collection

- A separate container for glass could be considered.
- Glass is problematic in mixed recycling because it's dirty and damages machinery.
- Many MRFs now remove glass at the beginning of the process.

Recycle Reform Act

- The EPR legislation (Recycle Reform Act) will offer reimbursements for recycling costs. It may change what and how things are recycled and how recycling appears on bills.
- Recycling is not free, but the cost is embedded to encourage participation.
- There is a possibility of people opting into different bin sizes.

Extended Producer Responsibility (EPR)

- The city of Seattle recycles 80,000 tons a year and will be reimbursed for all of that amount.
- One of the requirements is that the city has to show what that means across all of our customer base.
- EPR has passed for electronics, covering items like monitors, laptops, tablets, and phones.
- Recycling and disposal costs for covered electronics are paid for by a Producer Responsibility Organization (PRO).
- Textiles are a potential addition in the next contract, possibly through a pilot program.

Potential Recycling Solutions

- Considering a larger collection area, similar to smaller cities/towns, instead of special boxes.
- Turning the old south transfer station into a big recycling center is a possibility, but there is not enough space to build a MRF (Material Recovery Facility).

Incineration vs. Barging

- Barging is becoming more common because trains are becoming competitive for space and waste.
- Waste Connections is building a barge to transport garbage down the Columbia River to their landfill, as the Pierce County landfill is closing.
- Incineration is not publicly appreciated and would be costly and politically challenging to implement.

<u>Director's Rule and Operational Challenges</u>

- SPU, WM, and Recology aim to pick up all accumulated garbage after a storm without charging extra.
- Transfer stations must remain open seven days a week.

- Challenges arise in summer when routes are partially completed due to heat (e.g., 75% covered before 100-degree heat).
- Recology and WM must then pick up 125% the next day, which is difficult.
- Recycle is every other week, so you could be a month out if you miss a week.
- Escalations in the contact center are high during delays due to customer misunderstanding.

Wrap-up and Feedback

- There are many contracts expiring at different times.
- Feedback is wanted on the special item promotion.
- Feedback can be sent to the director, Sally Hulsman.

4. Solid Waste Amendments

- Aleema sent a letter to Council member Joy Hollingsworth last month (or in May).
- Angela briefed Council member Hollingsworth, who acknowledged the letter and expressed support.
- The amendments will go to committee and then to full council, with a decision expected in about two months

5. SWAC Recruitment Update

- There are five people to be recommended to the CEO and GM for approval to join SWAC.
- This would bring SWAC to a full 15 members.
- Communications are expected to go out tomorrow, with the goal of reaching out to candidates by mid- to late July.
- Joe, as vice chair, will step in as interim chair until the officer election in December.

- An August virtual ad hoc meeting will include onboarding information for new members.

- Ecology has been working on a new designated recyclables list workbook with recommendations on what Ecology has looked into for recycling.
